May kindly see the letter dated 31.3.2018 (at flag 'A') of Sri Umesh Kumar Sharma, District Judge, Amroha by which he has submitted his property statements for the financial years 2015-16 and 2016-17.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2015-16 and 2016-17 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

(1) In the statement of movable and immovable property for the financial years 2015-16, Sri Sharma's Income from salary and other Sources is Rs.17,44,732/- (Rs.16,83,056/- from Gross Salary, Rs.30,000/- from Agriculture, Rs.29,128/- from interests and Rs.2548/- from Hon. DLSA) from this amount, he has paid Rs.4800/- against GIS, Rs.1,61,986/- against CPF, Rs.2,70,000/- against Income Tax, Rs.35,000/- against PPF. The balance of his Saving Bank Account(s) enhanced for Rs.9,755/- this year against the balance of previous year. As such, total deductions /Savings/investment is Rs.4,81,541/-. Thus a sum of Rs.12,63,191/- was therefore available with him to meet out the household expenditure of his family consisting of five members in the financial year 2015-16.

(2) In the statement of movable and immovable property for the financial years 2016-17, Sri Sharma's Income from salary and other Sources is Rs.18,66,082/- (Rs.17,95,258/- from Gross Salary, Rs.30,000/- from Agriculture, Rs.28,824/- from interests and Rs.12,000/- from Hon. DLSA.) from this amount, he has paid Rs.5,000/- against GVR, Rs.4800/- against GIS, Rs.1,71,930/- against CPF, Rs.3,22,032/- against Income Tax, Rs.1,00,000/- against PPF. As such, total deductions /Savings/investment is Rs.6,03,762/-. The balance of his Saving Bank Account(s) decreased for Rs.4,61,472/- this year against the balance of previous year. Thus a sum of Rs.17,23,792/- was therefore available with him to meet out the household expenditure of his family consisting of five members in the financial year 2016-17.

The movable and immovable property statement for the financial year 2015-16 and 2016-17 has been submitted by the officer vide his letter dated 31.3.18 (flag 'A') which was due to be submitted in the financial year 2017-18 i.e. on before 31.3.18. As such there is no delay in submitting the Property statement for the aforesaid periods from the part of the officer.

In this connection, it is submitted that Sri Sharma has already submitted his property statement upto financial year 2014-15 which was seen by Hon'ble Mrs.

Justice Rekha Dikshit, the then Administrative Judge, Amroha Judgeship on dated 16.4.18 at flag 'Z' and the said statement is at flag 'M'.

May, if approved, the statements of movable and immovable property for the financial years 2015-16 and 2016-17 of Sri Umesh Kumar Sharma, District Judge, Amroha may kindly be laid before Hon'ble Mrs. Justice Rekha Dikshit, Administrative Judge, Amroha Judgeship for Her Lordship's kind perusal and orders?
