May kindly see the letter dated 06.01.2018 (placed below) of Sri Kamalkant Gupta, Civil Judge (Jr. Div.), Hapur duly forwarded by the District Judge, Hapur regarding inclusion of LL.M. qualification in his service records.

In this connection, it is submitted that earlier Sri Kamalkant Gupta has sent a letter dated 24.08.2017 (flagged at 'A') for grant of three advance increments on the basis of LL.M. qualification in accordance with order dated 03.05.2017 of the Hon'ble Court, passed in writ petition no. 1496 (S/B) of 2015- Sanjay Shankar Pandey and others Vs. State of U.P. and others. Vide this Court letter dated 30.10.2017, he was informed that qualification of LL.M. has not been included in his service records so far which is essential for further necessary action in the matter of granting three advance increments and also intimated to submit a representation regarding inclusion of degree of LL.M in his service record. In reply to which, he has sent letter dated 06.01.2018.

In this connection, it is submitted that Sri Kamalkant Gupta, Civil Judge (J.D), Hapur has joined U.P. Nyayik Sewa on 20.05.2013 (at Flag 'D'). He has completed LL.M. form Ch. Charan Singh University, Meerut in the year 2014 after joining the service with the permission of this Court (flagged at X) and attested copies of marksheets and degree of LL.M are placed at Flag 'B' & 'C' respectively.

It is further submitted that appointing authority of Judicial Officers is Government of U.P. The qualification of LL.M. may be included in the service records of Sri Kamalkant Gupta, Civil Judge (Jr. Div.), Hapur with the permission of Government of U.P., Lucknow. Therefore, it seems proper that the aforesaid application of Sri Kamalkant Gupta regarding inclusion of degree of LL.M. in his service records may be sent to Government of U.P. for obtaining necessary orders.

If approved by Hon'ble Mr. Justice Saumitra Dayal Singh, Administrative Judge, Hapur copy of letter dated 06.01.2018 of Sri Kamalkant Gupta, Civil Judge (Jr. Div.), Hapur regarding inclusion of qualification of LL.M in his service records, attested copies of marksheets & degree of LL.M and attested copy of form of U.P. Nyayik Sewa of Sri Kamalkant Gupta may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government in the matter?
