May Kindly see the letter, placed below at flag 'A' received from Sri Surya Kant Dhar Dubey, Judicial Magistrate, Siddharthnagar in which he has requested to the Court to grant him permission to appear in the Interview of U. P. Upper Subordinate Service Examination-2011.

In his letter dated 14-11-13 (flagged 'A'), Sri Dubey has stated that he is posted as Judicial Magistrate, Siddharthnagar and at present he is getting Induction training (first step) in J.T.R.I., Lucknow. He had appeared for the U. P. Upper Subordinate Service Examination-2011 before joining the Judicial Service and he has been declared as successful candidate in mains examination of the same which was held in December 2011. He has further stated that he has received Interview letter for 2nd December 2013 at UP Public Service Commission, Allahabad (Interview call letter is at flag 'D'). He has, therefore, requested the Court to grant her permission to appear in the Interview of the said examination.

In this connection, it is submitted that the officer has joined the U. P. Nyayik Sewa on 28-05-2013. It has been stated that he had appeared in examination of U.P. Upper Subordinate examination-2011 before joining the U. P. Judicial Service. He has qualified the examination, and accordingly requested for permission to appear in the Interview of the said examination. As he has qualified the examination permission for appearance in the Interview of the examination may be accorded, by way of issuance of 'No-Objection-Certificate', but subject to the following conditions: -

- (1) Government work should not suffer in any way.
- (3) No preferential treatment will be given in the matter of leave, postings and transfer.
