Sir,

With reference to the endorsement no.s 722/I & 723/I dated 02.05.2017 of the District Judge, Barabanki, on the above subject, I have to say that vide this Court's letter no. 8280/IV-3968/Admin.(A) dated 06.07.2017 which is addressed to you (photocopy enclosed for ready reference), Sri Pradeep Kumar Shukla, Additional Civil Judge (Jr. Div.), Aonla-Bareilly was asked to submit revised movable & immovable property statements at the time of joining into judicial service which must be properly filled with all the columns, but no reply has been received as yet. 
