May kindly see the application in Form 425-A (**at flag 'X'**) of Smt. Rekha Singh widow of late Dharam Vir Singh, the then Additional Civil Judge (Senior Division), Kanpur Nagar, for making payment of 90% amount of the balance, available in G.P. Fund Account No. L.J.U.-23170 of her husband Late Dharam Vir Singh who expired on 28.11.2008 as evident from death certificate, issued by the Registrar Birth & Death, Government of U.P. on 18.12.2008(**at flag 'Y'**).

The District Judge, Kanpur Nagar through his letter dated 25.07.2012(**at flag 'Z'**) has submitted original G.P.Fund Pass-Book of late Dharam Vir Singh, the then Additional Civil Judge (Senior Division), Kanpur Nagar along with three sets of calculation sheets of G.P.Fund, duly verified by the Drawing and Disbursing Officer, District Court, Kanpur Nagar from the financial year 2003-2004 to 2008-2009 together with three sets of application in Form 425-A with recommendation of the Chief Treasury Officer, Kanpur Nagar, for making payment of 90% amount of G.P.Fund Account No.L.J.U.-23170 in favour of his widow Smt. Rekha Singh.

As per G.P. Fund Pass-Book (**at flag 'A'**) of late Dharam Vir Singh and as per calculation sheets of his G.P. Fund for the financial years 2003-2004, 2004-2005, 2005-2006, 2006-2007, 2007-08 and 2008-2009 (**B,C,D,E,F and G**) a sum of Rs.2,98,371/-only is available in his G.P.Fund Account up to the date of his death(28.11.2008). Accordingly, the Drawing and Disbursing Officer, District Court, Kanpur Nagar as well as Chief Treasury Officer, Kanpur Nagar has recommended for making payment of Rs.2,68,534/-only in favour of his widow Smt. Rekha Singh, as 90% amount of his G.P.Fund, in her application Form 425-A at the place of Checking Accounts Authority Part of her application in Form 425-A (**at flag 'H'**) after checking calculation sheets of G.P. Fund of late Dharam Vir Singh.

After perusal of G.P. Fund Pass-Book of late Dharam Vir Singh it appears that Temporary Advance and Final Withdrawal are nil.

In this context it is submitted that the payment of 90% amount of G.P. Fund of deceased Judicial Officer is to be sanctioned by this Court in terms of G.O. No. Sa-4-A.G.-57/X-84-510-84, dated 26.12.1984 and Rule 22 of G.P. Fund (U.P.) Rules 1985 and General Provident Fund (Uttar Pradesh) (Second Amendment) Rule 2000 on submission of application in Form 425-A(Part-III and IV) of Nominee/Claimant(s) of G.P. Fund, of the deceased Judicial Officer, along with his G.P. Fund Pass-Book, prepared at least from the financial year 1985-1986 up to the month of his death and calculation sheets of his G.P. Fund of the current financial year as well as five preceding financial years, prepared on proforma parishishta-2 to this Court by the Incharge District Judge with recommendation of the Treasury Officer of concerned District, for payment of 90% amount of G.P. Fund of deceased Judicial Officer in favour of Nominee/Claimant(s) of G.P. Fund of the Judicial Officer as the case may be.

In view of the facts, mentioned above, if approved, by the Registrar (Budget), the file may be laid before Hon'ble Mr. Justice S.K. Singh, for His Lordship's kind perusal and order to the effect that a sum of Rs.2,68,534/- (Rs.Two Lacs Sixty Eight Thousand Five Hundred and Thirty Four) Only may be sanctioned in favour of Smt. Rekha Singh widow of late Dharam Vir Singh, the then Additional Civil Judge (Senior Division), Kanpur Nagar as 90% amount of his G.P. Fund, available in his G.P. Fund Account No.L.J.U.-23170 up to date of his death(28.11.2008) subject to the condition that in case of over payment, if any, reported later on, by office of the Accountant General(A.&E.)-II, U.P., Allahabad after reconciliation of his G.P. Fund Account, she will have to refund
