May kindly see the letters, placed below at flag 'A' & 'A-I' ^{& 'A-II'}, received from Smt. Sapana Tripathi, Additional Civil Judge (Sr. Div.), Kanpur Nagar regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by her or any member of her family for the financial years 2010-11 & 2011-12 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable property for the financial year 2010-11 & 2011-12 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2010-11, the income from salary is Rs.8,52,339/- and from this amount, Rs.1,40,263/- is deducted against GPF, Rs.1440 as GIS, Rs.1,07,400/- against Income Tax, Rs.2,17,000/- against LIC premium, Rs.5,000/- purchased NSC, Rs.20,000/- purchased Reliance Infrastructure bond, Rs.12,000/- deposited in his R.D. Account and Rs.70,000/- deposited in her PPF account in these years. As such, total deductions/repayment/savings/investment is Rs.05,73,103/- Thus, a sum of Rs.02,79,236/- was therefore available with her to meet out the household expenditure of her family consisting of four members in whole of the financial years 2010-11, and ~~2011-12~~

However, it is pertinent to mention here that the balance of saving bank account (s) of Smt. Sapana Tripathi is reduced to Rs.12,060/- against balance of previous year and her husband Sri Yogesh is a Sr. Manager, in N.T.P.C. and his income is Rs.12,00,000/- in the financial years 2010-11.

(2) In the financial years 2011-12, the income from salary is Rs.13,78,682/- and from this amount, Rs.2,40,969/- is deducted against GPF, Rs.3960/- as GIS, Rs.2,26,010/- against Income Tax, Rs.1,87,000/- against LIC premium, Rs.5,000/- purchased NSC, Rs.20,000/- purchased L & T Infrastructure bond, Rs.12,000/- deposited in his R.D. Account and Rs.1,00,000/- deposited in her PPF account in these years. The balance of her savings bank account (s) enhanced for Rs.93,865/- (including interest). As such, total deductions/repayment/savings/investment is Rs.08,88,804/- Thus, a sum of Rs.04,89,878/- was therefore available with her to meet out the household expenditure of her family consisting of four members in whole of the financial

years 2011-12.

However, it is pertinent to mention here that her husband's income is Rs.13,00,000/- in the financial years 2011-12. She has also received a sum of Rs. 34,953/- as interest of her PPF account and Rs. 17,000/- received from the LIC maturity amount.

In this connection it is submitted that last time, Smt. Sapana Tripathi had submitted her property statement of the financial year 2009-10 (statement is at flag 'M'), which had already been seen by Hon'ble Mr. Justice Krishna Murari, the then Administrative Judge, Mathura on 28-05-2012 at flag 'Z'.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the year 2010-11 & 2011-12 in its next financial year i. e. in 2012-13 up to March 2013. She has submitted the same through letter dated 24-06-2013 ^{firstly, however, it was incomplete} and as such, there is some delay in submitting the said statements.

May, therefore, if approved, the property statements for the financial years 2010-11 & 2011-12 alongwith letter dated 09-12-2013 (flagged 'A-I') of Smt. Sapana Tripathi, Additional Civil Judge (Sr. Div.), Kanpur Nagar be laid before Hon'ble Mr. Justice Krishna Murari, Administrative Judge, Kanpur Nagar Judgeship for His Lordship's kind perusal and orders?
