May kindly see the letter dated 21.11.2016 (flagged 'A') by which Smt. Sapna Tripathi, Additional District and Sessions Judge, Bulandshahr has submitted her details of Insurances policies and PPF A/cs. In connection with submission of property statements for the financial years 2012-13 and 2013-14.

Earlier Smt. Tripathi has submitted his property statement for the financial years 2012-13 and 2013-14 and 2014-15 vide his letter dated 14.7.2016(flag 'B') but in which she has not furnished the immovable property statements for the financial years 2012-13, 2013-14 and 2014-15 separately, also not mentioned the balance of her Saving Bank Accounts at the end of the financial years, details of NSC and R.D. A/cs and reasons for delayed submission of the aforesaid statements hence a Court's letter dated 17.8.2016(flag 'C') has been sent to the officer in this regard. In reply officer has submitted the revised property statements for the financial years 2012-13, 2013-14 and 2014-15 vide his letter dated 7.9.2016(flag 'D') again in which some informations like details of NSC, R.D.A/cs., Insurances and what amount deposited in PPF A/c in each financial years has not been mentioned by her. Therefore a letter dated 22.10.2016(flag 'E') has been sent to the officer in this regard.

In reply of aforesaid Court's letter, officer has submitted ~~her~~ her details of Insurances policies and PPF A/cs in connection with submission of property statements for the financial years 2012-13 and 2013-14 vide her letter dated 21.11.2016 (flag 'A').

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2012-13 and 2013-14, of the officer concerned, details of income, deductions, Savings, investment and expenditure made by her are given below.

(1)In the financial year 2012-13, Annual income from Salary and other Sources of Smt Tripathi is Rs.9,65,489/- (Rs.9,26,688/- from Salary and Rs.38,801/- from interest of PPF) from this amount Rs.88,591/- is deducted against GPF, Rs.4800/- against GIS, Rs.89,422/- against Income Tax, Rs.176630/- against Insurances and Rs.100,000/- against PPF. As such, total deductions/ repayment/ Savings/investment is Rs.4,59,443/-. The balance of his Saving Bank Account(s) decreased for Rs.1,95,283/- this year against the balance of previous year. Thus a sum of Rs.7,01,329/- was therefore available with her to meet out the household expenditure of his family consisting of four members in the financial year 2012-13.

(2)In the financial year 2013-14, Annual income from Salary and other Sources of Smt Tripathi is Rs.10,67,668/- (Rs.10,17,957/- from Salary and Rs.49,711/- from interest of PPF) from this amount Rs.92,475/- is deducted against GPF, Rs.4800/- against GIS, Rs.1,07,708/- against Income Tax, Rs.1,66,630/- against Insurances and Rs.100,000/- against PPF. As such, total deductions/ repayment/ Savings/investment is Rs.4,71,613/-. The balance of his Saving Bank Account(s) decreased for Rs.52,448/- this year against the balance of previous year. Thus a sum of Rs.6,48,503/- was therefore available with her to meet out the household expenditure of his family consisting of four members in the financial year 2013-14.

However, it is pertinent to mention here that the husband of the officer Sri Yogesh Tripathi is Sr. Manager, in NTPC, whose annual income is Rs.15,53,249/- (in the financial year 2012-13) and Rs.18,38,470/- (in the financial year 2013-14)

The property statement for the financial year 2012-13 and 2013-14 has been submitted by the officer ^{her} vide her letter dated 14.7.2016 (flag 'B'). The movable and immovable property statement for the financial years 2012-13 and 2013-14 was due

to be submitted in third financial years 2014-15. As such there is delay in submitting the Property statement for the financial years 2012-13 and 2013-14 from the part of the officer. The property statement for the financial year 2014-15 alongwith property statement for the financial year 2015-16 will be due in the financial year 2016-17 vide Court's Circular letter dated 13.5.204 and the same will be dealt when officer will submit the property statement for the financial year 2015-16.

In this connection it is submitted last time Smt. Tripathi had submitted her property statement upto financial year 2011-12 which had been seen by Hon'ble Mr. Justice Krishna Murari, the then Administrative Judge, Kanpur-Nagar Judgeship on 8.2.2014, which is at flag 'Z' and the said statement at flag 'M'.

May, if approved, the statements of movable and immovable property for the financial years 2012-13 and 2013-14 of Smt. Sapna Tripathi, Additional District and Sessions Judge, Bulandshahr may kindly be laid before Hon'ble Mr. Justice S.N.Shukla, Administrative Judge, Bulandshahr Judgeship for His Lordship's kind perusal and orders?
