May kindly see the letter dated 7.9.16 and 11.4.2018 (at flag 'A' and 'A-1') of Smt. Sapna Tripathi, Additional District and Sessions Judge(FTC), Bulandshahr by which she has submitted her Property statement for the financial years 2014-15, 2015-16 and 2016-17.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2014-15 and 2015-16 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by her are given below:-

- (i) In the statement of movable and immovable property for the financial year 2014-15, Smt. Tripathi annual income from salary and other Sources is Rs.12,14,865/- (Rs.1142458/- from Salary, Rs.57,407/- from EEL and Rs. 15,000/- income from LIC) from this amount Rs.92,475/- deducted against GPF, Rs.4800/- against GIS, Rs.107708/- against Income Tax, Rs.65,000/- against PPF, Rs.66,640/- against LIC. The balance of her Saving bank account(s) enhanced for Rs.2,65,270/- this financial year. As such, total deductions/Saving/investment is Rs.6,01,893/- . Thus a sum of Rs.6,12972/- was therefore available with her to meet out her household expenditure of her family consisting of four members in financial years 2014-15.
- (ii) In the statement of movable and immovable property for the financial year 201*G*-1*G*, Smt. Tripathi annual income from salary and other Sources is Rs.13,69,259/- (Rs.13,47,659/- from Salary and Rs.21,600/- from maturity of REC Bond) from this amount Rs.76,720/- deducted against GPF, Rs.4800/- against GIS, Rs.1,89,900/- against Income Tax, Rs.50,000/- against PPF, Rs.144000/- towards repayment of car loan, Rs.66,640/- against LIC, Rs.81,000/- against Sukanya Samridhi Yogna and Rs.1,00,000/- against SBI Life Insurances. As such, total deductions/Saving/investment is Rs.7,12,950/-. The balance of her Saving bank account(s) decreased for Rs.1,32,566/- this financial year against the balance of previous year. Thus a sum of Rs.7,88,875/- was therefore available with her to meet out her household expenditure of her family consisting of four members in financial years.

And as per two years block policy, the property statement for the financial year 2016-17 will be taken up for consideration alongwith property statement for the financial year 2017-18, which will be submitted by the officer in near future, be due in the financial year 2018-19

It is pertinent to mention here that the husband of the officer Sri Yogesh Tripathi is Sr. Manager, NTPC whose annual income is Rs.18,38,470/- (in the
