Smt Sabna Mishra, the then Special Judicial magistrate, Ghaziabad, now posted as Additional Civil Judge (Senior Division), Mathura has given another application dated 19.8.09 for change of her name from Sabna Mishra Tripathi to Sabna Tripathi placed below at flag 'A'.

It may be recalled that earlier Smt Sabna Mishra Tripathi had given application for change of her name from Sabna Mishra to Sabna Mishra Tripathi as her marriage solemnized with Yogesh Tripathi on 27.6.04. Her earliest application is at flag 'P'.

Accordingly the order dated 09.5.2007 was obtained from the Home Administration Judge, Ghaziabad and the application of Smt Sabna Mishra was forwarded to the Under Secretary, Appointment Section, Government of U.P. Lucknow through the Court's letter dated 28.05.07 (flagged 'B') for obtaining the orders.

Through the office memorandum No. 4099 (क्रमांक C), 1/I-4-2007-26/2(9) /2007 dated 05.12.07, the Government has informed that
