Smt Sapna Mishra the then Special Judicial Magistrate, Ghaziabad, now posted as Additional Civil Judge (Senior Division), Mathura has given another application dated 19.8.07 for change of her name from Sapna Mishra Tripathi to Sapna Tripathi placed below at flag A.

It may be recalled that earlier Smt Sapna Mishra Tripathi ^{had} given application for change of her name from Sapna Mishra to Sapna Mishra Tripathi as her marriage solemnized with Yogesh Tripathi on 27.8.04. Her earlier application is at flag 'P'.

Accordingly the order dated 09.5.2007 was obtained from the Honble Administrative Judge, Ghaziabad and the application of Smt Sapna Mishra was forwarded to the Under Secretary, Appointment Section-4, Government of U.P. Lucknow through the Court's letter dated 28.05.07 (Flagged B) for obtaining the orders.

Through the office memorandum No. 4099 (H.C.) / II-4.2007-26/2(9)/2007 dated 05.12.07, the Government has informed that
