May kindly see the letter dtd. 07.07.2015, placed below at flag '1' received from Sri Rajendra- Kumar Singh, Additional Civil Judge (Junior Division), Azamgarh in the matter regarding grant of permission to purchase house, measuring 2448 sq. feet, Arazi no. 560/2/1 and 561, situated at Mohalla- Humaunpur North, Tappa-Paragna- Haweli, Tehsil- Sadar, District- Gorakhpur.

In this connection, it is submitted that earlier the officer vide his letters dtd. 17.03.2015 & 04.02.2015 (flags 'A' & 'A-1') has requested for grant of permission to purchase the above mentioned house for Rs. 44,00,000/- and furnished details of source of money. Accordingly, through earlier detailed office note dtd. 15.04.2015 (flag '2') matter was submitted to the Hon'ble Judge Mr. Justice Sudhir Agarwal but the file was received back without order as His Lordship wants salary details (income/expenditure) for the last ten years and approved a draft proforma in which the officer has been asked to submit information about the assets declared by him at the time of entry in service and subsequent additional alterations, showing value, date of purchase etc. also.

Accordingly, required details were asked from the officer vide Court's letter dtd. 16.06.2015 (flag '3').

In reply of the Court's letter dtd. 16.06.2015 (flag '3'), Sri Singh has submitted copy of assets (both movable & immovable) held by him at the time of entering service & onwards (i.e. copy of property statements) (starting from flag '4'). He has also furnished statement of details of earning/salary and deduction/expenditure/savings/house hold expenses etc. right from the year 2007-08 till now (flag '5'). Earlier, he was in Bihar Judicial Service from the year 2007 and all the S.B. accounts and F.D.Rs shown by him in his first statement of property in U.P. Judicial service. He has also shown income of his wife from teaching as Rs. 72,000/- per annum. Apart from proposed bank loan of Rs. 3,50,000/- rest of the payment is proposed to be ^{taken} ~~kame~~ from bank accounts and two F.D.Rs of Rs. 1,00,000/- each. He has submitted copies of pass book of bank accouns, starting from flag 'D' and afterwards also, which apparently co-relates to his statement of income/deductions/savings/house hold expenses (flag '5'). Acceptance of papers and details submitted by the officer is on the discretion of the Court.

Tehsil- Sadar, District- Gorakhpur for Rs. 44,00,000/-, as per earlier proposal already submitted in earlier office note dated 15.04.2015 (flag '2')?
