May kindly see the letter, placed below at flag 'A', received from Smt. Pragma Singh, Additional Civil Judge (Jr. Div.), Shahjahanpur regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by her or any member of her family for the financial years 2013-14 and 2014-15 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2013-14 & 2014-15 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial year 2013-14 & 2014-15, the income from salary is Rs.09,17,942/- and from this amount, Rs.98,534/- is deducted against PRAN, Rs.4000/- against GIS, Rs.37,780/- against Income Tax and Rs.1,85,293/- deposited in his PPF account in this years. The balance of his savings bank account (s) enhanced for Rs.4,11,377/- this year. As such, total deductions/ repayment is Rs.07,36,984/-. Thus, a sum of Rs.1,80,958/- was therefore available with her to meet out the household expenditure of her family consisting of three members in whole of the financial year 2013-14 & 2014-15.

However, it is pertinent to mention here that her husband Sri Neerj Kushwaha, is Judicial Magistrate in shahjahanpur, and his income is Rs. 58,751/- per month.

In this connection it is submitted that Smt. Pragma Singh has already submitted his property statement at the time of entering into Judicial Service (statement is at flag 'M') which had already been seen on 04-03-2016 by Hon'ble Mr. Justice Harsh Kumar, the then Administrative Judge, Shahjahanpur Judgeship at flag 'Z'.

It is further submitted that as as per policy/Court's Circular Letter, the officer has to submit his property statement for the years 2013-14 & 2014-15 in its

next financial year i. e. in 2015-16 up to March 2016. She has submitted the movable and immovable property statement for the financial year 2013-14 & 2014-15 vide her letter dated 05-02-2016, as such, there is no delay in submitting the same statements for the years 2013-14 & 2014-15.

May, therefore, if approved, the property statements for the financial years 2013-14 & 2014-15 alongwith letter dated 05-02-2016 (flagged 'A') of Smt. Pragya Singh, Additional Civil Judge (Jr. Div.), Shahjahanpur be laid before Hon'ble Mr. Justice Manoj Kumar Gupta, Administrative Judge, Shahjahanpur Judgeship for his Lordship's kind perusal and orders?
