May Kindly see the letter, placed below at flag 'A', received from Sri Himanshu Mishra, Additional Civil Judge, (Jr. Div.), Basti by which he has requested for grant of permission to appear in UPSC; Civil Services Examination, 2014.

In his letter, Sri Himanshu Misra has stated that he is posted as Additional Civil Judge (Jr. Div.), Basti (UP) since 31-05-2013 and presently undergoing Induction training programme in JTRI, U.P., Lucknow. He has further stated that he is interested to appear for Civil Servies Examination 2014 scheduled to be held on 24-08-2014. He has also enclosed the copy of t he advertisement of the said examination. He has, therefore, requested the Court to grant him permission to appear in the said examination.

In this connection, it is submitted that the officer has joined the U.P. Nyayik Sewa on 31-05-2013. It is desirable that he may be accorded permission to appear in preliminary examination of Civil Services Examination 2014 at present, if the Court so desires. Permission to appear in such type of written examination may be accorded, but subject to the following conditions: -

- (1) Government work should not suffer in any way.
- (2) No preferential treatment will be given in the matter of leave, postings and transfer.
- (3) The permission can be withdrawn without notice if; it is found at any time that the government servant neglect his normal work or that public work suffers, in any way.

May, therefore, if approved by Hon'ble Mr. Justice Ashok Pal Singh, Administrative Judge, Basti Judgeship, permission be accorded to Sri Himanshu Mishra, Additional Civil Judge (Jr. Div.), Basti to appear in preliminary examination of Civil Services Examination, 2014, as requested, subject to the conditions mentioned above?
