May Kindly see the letter, placed below at flag 'A', received from Sri Himanshu Misra, Additional Civil Judge (Jr. Div.)/ Judicial Magistrate, Basti by which he has requested for grant of permission to appear in Utrakhand Judicial Service, Civil Judge (Jr. Div.) Examination, 2014.

In his letter, Sri Himanshu Misra has stated that he wants to appear in the Utrakhand Judicial Service, Examination, 2014 conducted by Advertisement no. A-2/ E-2/ 2014-15 of Utrakhand Government for which permission of Hon'ble High Court is required. He has, therefore, requested the Court to grant him permission to appear in the aforesaid examination.

In this connection, it is submitted that the officer has joined the U.P. Nyayik Sewa on 31-05-2013. It is desirable that he may be accorded permission to appear in preliminary examination of Utrakhand Judicial Service, 2014 at present, if the Court so desires. Permission to appear in such type of written examination may be accorded, but subject to the following conditions: -

- (1) Government work should not suffer in any way.
- (2) No preferential treatment will be given in the matter of leave, postings and transfer.
- (3) The permission can be withdrawn without notice if; it is found at any time that the government servant neglect his normal work or that public work suffers, in any way.

May, therefore, if approved by Hon'ble Mr. Justice Ashok Pal Singh, Administrative Judge, Basti Judgeship, permission be accorded to Sri Himanshu Misra, Additional Civil Judge (Jr. Div.) / Judicial Magistrate, Basti to appear in preliminary examination of Utrakhand Judicial Service, conducted by Advertisement no. A-2/ E-2/ 2014-15 of Utrakhand Government, as requested, subject to the conditions mentioned above?
