May Kindly see the letter, placed below at flag 'A', received from Sri Malkhan Singh, Additional District & Session Judge, Mainpuri in which he has requested to the Court to grant him permission to appear in the examination of Higher Super Judicial Service (District Judge Cadre) Haryana, to be conducted by the Hon'ble High Court of Punjab & Haryana at Chandigarh.

In his letter, Sri Malkhan Singh has stated that he was appointed as Additional District & Session Judge at Mainpuri vide Notification No. 1071/DR (S)/2013, dated August 16, 2013 and joined for the same post on 19-08-2013. Before Joining the Service he had already applied the application for the post of Additional District & Session Judge in Haryana Super Judicial Service which was notified by notification No. 64 dated 29-04-2013 and last date for submission of application form was 07-06-2013. The preliminary examination for the same is going to be held on 22-09-2013 at Chandigarh. He had received his admit card at his permanent residence at Karnal (Haryana) on 11-09-2013. He has, therefore, requested the Court to grant him permission to appear in the aforesaid examination.

In this connection, it is submitted that the officer has joined the U. P. Higher Judicial Service-2012 vide notification 16-08-2013. It is further submitted that in the notification dated 29-04-2013 (flagged 'B') of High Court of Punjab and Haryana at Chandigarh it is mention that the applicant must have been duly enrolled as an Advocate and has practiced for a period not ^{less} than seven years as on the last date of submission of application i.e. 07-06-2013. It is supposed that Sri Singh should have a practicing Advocate with nine years experience on the last date of submission of application i.e. 07-06-2013 of examination of Higher Super Judicial Service (District Judge Cadre) Haryana, to be conducted by the Hon'ble High Court of Punjab & Haryana at Chandigarh and this dated falls before his joining in U.P. Higher Judicial Service i. e. 19-08-2013. As such he appears to be eligible for submitting application for the same examination. Now as he has joined the U.P. Higher Judicial Service, his request for grant of permission to appear in preliminary examination of Higher Super Judicial Service (District Judge Cadre) Haryana, to be conducted by the Hon'ble High Court of Punjab & Haryana at Chandigarh is on the discretion of the Court.

If such permission has been granted to him following conditions may be imposed.

- (1) Government work should not suffer in any way.
- (2) No preferential treatment will be given in the matter of leave, postings and transfer.
- (3) The permission can be withdrawn without notice if; it is found at any time that the government servant neglect his normal work or that public work suffers, in any way.

May, therefore, if approved the file be laid before Hon'ble Mr. Justice Ashok Srivastava, Administrative Judge, Mainpuri, for kind perusal and if His Lordship's approval Sri Malkhan Singh, Additional District & Session Judge, Mainpuri be granted permission to appear in preliminary examination of Higher Super Judicial Service (District Judge Cader) Haryana to be conducted by the Hon'ble High Court of Punjab & Haryana at Chandigarh.
