May Kindly see the letter, placed below at flag 'A', received from Sri Malkhan Singh, Additional District & Session Judge, Mainpuri in which he has requested to the Court to grant him permission to appear in the main examination of Higher Super Judicial Service (District Judge Cadre) Haryana, to be conducted by the Hon'ble High Court of Punjab & Haryana at Chandigarh .

In his letter, Sri Malkhan Singh has stated that he was appointed as Additional District & Session Judge at Mainpuri vide Notification No. 1071/DR (S)/2013, dated August 16, 2013 and joined for the same post on 19-08-2013. Before Joining the Service he had already applied the application for the post of Additional District & Session Judge in Haryana Super Judicial Service which was notified by notification No. 64 dated 29-04-2013 and last date for submission of application form was 07-06-2013. The preliminary examination for the same was held on 22-09-2013 at Chandigarh and he has qualified for the main examination to be held on 22,23,24 of November 2013 and he was given permission by the Hon'ble Court vide letter no. 13868/IV-4036/Admin (A) dated 30-09-2013 to appear in the preliminary examination. He has, therefore, requested the Court to grant him permission to appear in the main examination to be held on 22, 23, 24 of November 2013.

In this connection, it is submitted that the officer has joined the U. P. Higher Judicial Service-2012 on 19-08-2013. Earlier he had been granted permission to appear in preliminary examination of Higher Super Judicial Service (District Judge Cader) Haryana to be conducted by the Hon'ble High Court of Punjab & Haryana at Chandigarh as requested, vide Court's Order at flag 'O' communicated vide court's letter dated 30-09-2013, <sup>(Happad B)</sup> He appeared in the preliminary examination of the aforesaid examination. However, he has again requested to grant him permission to appear in its mains examination of the service, as he has qualified the preliminary examination. Permission to appear in such type of written examination is on the discretion of the Court. If such permission has been granted to him, following conditions may be imposed.

- (1) Government work should not suffer in any way.
- (2) No preferential treatment will be given in the matter of leave, postings and transfer.

(3) The permission can be withdrawn without notice if; it is found at any time that the government servant neglect his normal work or that public work suffers, in any way.

May, therefore, if approved the file be laid before Hon'ble Mr. Justice Ashok Srivastava, Administrative Judge, Mainpuri, for kind perusal and if His Lordship's ~~appears~~ <sup>approves</sup> Sri Malkhan Singh, Additional District & Session Judge, Mainpuri be granted permission to appear in mains examination of Higher Super Judicial Service (District Judge Cader) Haryana to be conducted by the Hon'ble High Court of Punjab & Haryana, at Chandigarh.
