May Kindly see the letter, placed below at flag 'A', received from Sri Malkhan Singh, Additional District & Sessions Judge, Mainpuri in which he has requested to the Court to grant him permission to appear in the Interview/Viva-Voce of Higher Super Judicial Service (District Judge Cadre) Haryana, to tea conducted by the Hon'ble High Court of Punjab & Haryana at Chandigarh.

In this connection, it is submitted that the officer has joined the U. P. Higher Judicial Service-2012 on 19-08-2013. Earlier he was granted permission to appear in preliminary examination of Higher Super Judicial Service (District Judge Cader) Haryana to be conducted by the Hon'ble High Court of Punjab & Haryana at Chandigarh as requested, vide Court's Order at flag 'M', communicated vide Court's letter dated 30-09-2013 (flagged 'C-I'). He appeared in the preliminary examination of the said examination and was qualified for the main examination and he was given permission to appear in the mains examination vide Court Order flagged 'O' communicated vide Court's letter dated 12-11-2013 (flagged 'C-II'). Thereafter, he has qualified for the Interview/ Viva-Voce of Higher Super Judicial Service (District Judge Cadre) Haryana. New, he has requested to grant him permission to appear in Interview which was fixed on 04-02-2014 through his letter dated 23-01-2014 (flagged 'P'). The aforesaid letter was marked to undersigned on 12-02-2014 (after the date of Interview/ Viva-Voce of Higher Super Judicial Service (District Judge Cadre) Haryana). As such, he was asked to intimate the Court as to whether he had appeared in the Interview/Viva-Voce examination of Higher Super Judicial Service (District Judge Cader) Haryana on 04-02-2014, in anticipation of Court's permission vide Court's letter dated 19-02-2014 (flagged 'C').

Now, in reply of Court's letter dated 19-02-2014, Sri Malkhan Singh has sent a letter dated 11-03-2014 (flagged 'A') in which he has stated that he had appeared in the Interview of the aforesaid examination after taking casual leave from the Director JTRI, Lucknow. He was given permission by the Director in anticipation of the Court's permission, as he was already granted permission by the Hon'ble High Court for appearing in preliminary and the mains examination.

In this connection, it is further submitted that the officer has joined the U. P. Higher Judicial Service-2012 on 19-08-2013 and he appeared in the

preliminary and mains examination of the aforesaid examination after permission of the Hon'ble High Court. He has qualified the aforesaid examination, and accordingly requested for permission to appear in the Interview of the said examination. Permission to appear in such type of Interview examination is on the discretion of the Court. If such permission has been granted to him following conditions may be imposed.

- (1) Government work should not suffer in any way.
- (2) No preferential treatment will be given in the matter of leave, postings and transfer.
- (3) The permission can be withdrawn without notice if; it is found at any time that the government servant neglect his normal work or that public work suffers, in any way.

May, therefore, if approved the file be laid before Hon'ble Mr. Justice Ram Surat Ram (Maurya), Administrative Judge, Mainpuri, for kind perusal and if His Lordship approves, Sri Malkhan Singh, Additional District & Sessions Judge, ex-pot-facto Mainpuri be granted permission to appear in the Interview/Viva-Voce of Higher Super Judicial Service (District Judge Cadre) Haryana, to be conducted by the Hon'ble High Court of Punjab & Haryana at Chandigarh
