May kindly see the letter, placed below at flag 'A' received from Sri Malkhan Singh, Additional District & Sessions Judge, Allahabad regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family at the time of entering into Judicial Service and for the financial years 2013-14 and 2014-15 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable property at the time of entering into Judicial Service and for the financial years 2013-14 and 2014-15 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

He has also Agricultural land about 72 Kanal 06 Marlae at village aible khalsa, Tehsil Nilokheri, District Karnal, Haryana, agricultural land in the name of his mother Smt. Kamla Devi about 38 Kanal at village Albli Khals, Tehsil Nilokheri, District Karnal, Haryana, 1/2 share in 1440 sq. ft. house no. 1859, Sector-9, Karnal Haryana, 1/3 share in 1000 sq. yards Residential House at village Aibli Khalsa, Tehsil Nilokheri, District Karnal, Haryana and one furnished chamber of size 9x12 sq. ft. Advocates Chamber no. 179, Lawyer's Chamber complex, District Court, Karnal.

(1) In the financial year 2013-14 the income from salary is Rs.6,58,803/- for seven months as he had joined that year on 19-08-2013 and from this amount, Rs.2800/- is deducted against GIS, Rs.50,000/- against FDR, Rs.52,286/- against Income Tax, and Rs.91,500/- against car loan and Rs.8,000/- against Interest of

Kisan Credit card. The balance of his savings bank account (s) enhanced for Rs.1,97,662/- (including interest). As such, total deductions/ repayment/ savings/ investment is Rs.4,02,248/-. He has also received Rs.1,05,500/- as Agricultural income and Rs.15,023/- as interest from his savings bank account. Thus a sum of Rs.3,77,078/- was therefore available with him to meet out the household expenditure of his family consisting of six members in seven months in the financial year 2013-14.

However, it is pertinent to mention here that his wife Smt. Sneha Lata is working as teacher in Haryana Education Deptt. Posted at village kulwehri, District : Karnal and her income is Rs.05,43,478/- per annum.

(2) In the financial year 2014-15 the income from salary is Rs.12,91,743/- and from this amount, Rs.4800/- is deducted against GIS, Rs.3,000/- against LIC, Rs.1,84,440/- against Income Tax, and Rs.1,74,000/- against car loans, Rs.1,50,000/- against FDR, Rs.6,830/- against Mediclaim and Rs.16,000/- against Interest of Kisan Credit card. As such, total deductions/ repayment/ savings/ investment is Rs.5,39,070/-. The balance of his savings bank account (s) reduced for Rs.2,81,190/- (including interest). He has also received Rs.1,00,000/- as Agricultural income and Rs.38,790/- as interest from his savings bank account. Thus a sum of Rs.8,91,463/- was therefore available with him to meet out the household expenditure of his family consisting of six members in seven months in the financial year 2014-15.

However, it is pertinent to mention here that his wife's income is Rs.06,80,542/- per annum.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement at the time of entering into Judicial service Just after Joining the Judicial Service i. e. after 19-08-2013 but Sri Singh has submitted the same on 16-09-2015, there is delay in submitting the said statements. The statement for the year 2013-14 and 2014-15 in its next financial year i. e. in 2015-16 up to March 2016 He has submitted the same through letter dated 16-09-2015 and as such, there is no delay in submitting the said statements. He has not submitted the aforesaid property statements within due time due to unavoidable circumstances i.e. misplacement of the record of the property , for

which he has regretted in his letter dated 16-09-2015 (flagged 'A') has stated that in future the property statements shall be filed within time.

May, therefore, if approved, the property statements at the time of entering into Judicial Service and for the financial years 2013-14 and 2014-15 alongwith letter dated 16-09-2015 (flagged 'A') of Sri Malkhan Singh, Additional District & Sessions Judge, Allahabad be laid before Hon'ble Mr. Justice Pankaj Mithal, Administrative Judge, Allahabad Judgeship for His Lordship's kind perusal and orders?
