May kindly see the letter dated 29.7.2017 of Sri Malkhan Singh, Additional District and Sessions Judge, Allahabad by which he has submitted his movable and immovable property statements for the financial years 2015-16 and 2016-17.

(5) In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2015-16 and 2016-17 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

(1) In the statement of movable and immovable property for the financial year 2015-16, Sri Singh's Gross Income from Salary is Rs.14,80,877/- from this amount, he has paid Rs.4800/- against GIS, Rs.194596/-, Rs.56059/- against PRAN, Rs.114000/- towards loan, Rs.150000/- against FDR, Rs.1,50,000/- against PPF, Rs.16,000/- against interest of Kisan credit card. The balance of his Saving Bank Account(s) enhanced for Rs.2,60,201/- this year against the balance of previous year. As such, total deductions /Savings/investment is Rs.9,45,656/-. Thus a sum of Rs.5,35,221/- was therefore available with him to meet out the household expenditure of his family consisting of five members in the financial year 2014-15.

(2) In the statement of movable and immovable property for the financial year 2016-17, Sri Singh's Gross Income from Salary is Rs.16,21,776/- from this amount, he has paid Rs.4800/- against GIS, Rs.2,25,550/- against Income Tax, Rs.3,11,011/- against PRAN, Rs.1,14,000/- towards loan, Rs.1,50,000/- against PPF, Rs.16,000/- against interest of Kisan credit card. The balance of his Saving Bank Account(s) enhanced for Rs.2,95,765/- this year against the balance of previous year. As such, total deductions /Savings/investment is Rs.11,17,126/-. Thus a sum of Rs.5,04,650/- was therefore available with him to meet out the household expenditure of his family consisting of five members in the financial year 2015-16.

The movable and immovable property statement for the financial years 2015-16 and 2016-17 has been submitted by the officer vide his letter dated 29.7.17 (flag 'A') which was due to be submitted in the financial year 2017-18 i.e. on or before 31.3.18. As such there is no delay in submitting the aforesaid Property statement from the part of the officer.

It is pertinent to mention here that the wife of the officer Smt. Snehlata is teacher in Haryana Education Department whose annual Salary is Rs.6,85,272/- (in the financial year 2015-16) and Rs.8,51,516/- (in the financial year 2016-17)

In this connection, it is submitted that Sri Singh has already submitted his
