May kindly see the letter dated 8.4.19(flag 'A') of Sri Malkhan Singh, O.S.D.(J)(Infra-HC), High Court, Allahabad by which he has submitted his consolidated movable and immovable property statements for the financial years 2017-18 and 2018-19.

(11) In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2017-18 and 2018-19 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

In the consolidated statement of movable and immovable property for the financial years 2017-18 and 2018-19, Sri Singh's total income from Salary and other Sources is Rs.44,37,666/- (is Rs.41,75,857/- from gross Income from Salary, Rs.1,87,769/- from Bank interest and Rs.74,040/- from maturity of F.D.) from this amount, he has paid Rs.9200/- against GIS, Rs.7,50,171/- against Income Tax, Rs.3,98,083/- against PRAN, Rs.3,00,000/- against PPF, Rs.32,000/- against interest of Kisan credit card and R.1,50,000/- against Sukanya Samriddhi Yogna. The balance of his Saving Bank Account(s) enhanced for Rs.15,06,349/- this year against the balance of previous year. As such, total deductions /Savings/investment is Rs.31,45,803/-. Thus a sum of Rs.12,91,863/- was therefore available with him to meet out the household expenditure of his family consisting of five members in the financial years 2017-18 and 2018-19.

The movable and immovable property statement for the financial years 2017-18 and 2018-19 has been submitted by the officer vide his letter dated 8.4.19(flag 'A') which was due to be submitted in the financial year 2019-20 i.e. on or before 31.3.20. As such there is no delay in submitting the aforesaid Property statement from the part of the officer.

It is pertinent to mention here that the wife of the officer Smt. Snehlata is teacher in Haryana Education Department whose annual Salary is Rs.9,48,558/-.

In this connection, it is submitted that Sri Singh has already submitted his property statement upto financial year 2016-17 which was seen by Hon'ble Mr. Justice Bala Krishna Narayana, Administrative Judge, Allahabad
