May kindly see the letter, placed below at flag 'A', received from Sri Narendra Kumar Jha, Additional District & Sessions Judge/ Special Judge (D.A.A. Act), Banda regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family at the time of entering into Judicial service and for the financial years 2013-14 and 2014-15 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that Sri Narendra Kumar Jha has joined U.P. Judicial Service on 19.08.2013 and as per statement of movable and immovable property at the time of entering into Judicial service and for the financial years 2013-14 and 2014-15 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) At the time of entering into U.P. Judicial service, Officer has:-

- ornaments of Gold (200 gm approx.) & Silver (500 gm approx.) was obtained by wife at the time of marriage in the year 2006 and Motor Car Honda Amaze purchased on 19.04.2013 by taking loan of Rs.5,40,000/- from State Bank of India.
- Savings bank accounts in Bank of India a/c no.30002004158 & his wife's a/c no.20008645840 having balance of Rs.32,494/- & Rs.1,065/- respectively.
- Two FDs of Rs.1,82,595/- each and one FD of Rs.2,55,323/- in the name of her wife
- Various Insurance policies in the name of himself, wife & his son with the premium of Rs.86,493/- yearly.

(2) In the financial year 2013-14 (i.e., from 19.08.2013 to 31.03.2014), income from salary is Rs.6,08,054/- and from this amount, Rs.2,800/- is deducted against GIS, Rs.48,000/- against Income Tax, Rs.98,603/- against premium of insurance policies and Rs.1,12,200/- against Car loan. The balance of his savings bank account(s) enhanced for Rs.8,606/- this financial year from previous year's balance. As such, total deductions/ repayment/ savings/ investment is Rs.2,70,209/-. Thus, a sum of Rs.3,37,845/- was therefore available with him to meet out the household expenditure of his family consisting of four members in eight months (around) of the financial year.

(3) In the financial year 2014-15, income from salary is Rs.13,49,209/- and from this amount, Rs.4,800/- is deducted against GIS, Rs.54,462/- against PRAN, Rs.1,58,000/- against Income Tax, Rs.1,32,470/- against premium of insurance policies and Rs.1,12,200/- against Car loan. As such, total deductions/ repayment/ savings/ investment is Rs.4,61,932/-. The balance of his savings bank account(s) reduced for Rs.9,432/- this financial year from previous year's balance. Thus, a sum of Rs.8,96,709/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial year.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement at the time of entering into Judicial service after joining into Judicial service, for the financial year 2013-14 & 2014-15 in its next financial year i.e., 2015-16 upto march 2016. He has submitted the movable and immovable property statement at the time of entering into Judicial service and for the financial years 2013-14 & 2014-15 vide his letter dated 28.04.2017 (at flag 'A'). As such, there is delay in submitting the property statements at the time of entering into Judicial service and for the financial years 2013-14 and 2014-15 from the part of the officer.
