May kindly see the letters dated 19.8.2017 (flagged 'A') by which Sri Sunil Kumar-V, Additional District and Sessions Judge, Bijnor has submitted his movable and immovable property statement at the time of joining the Higher Judicial Service and for the financial years 2013-14 (i.e. from 19.8.13 to 31.3.14) and 2014-15.

In this connection, it is submitted that as per statement of movable and immovable property at the time of joining the Higher Judicial Service and for the financial years 2013-14 and 2014-15 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below.

- (1)At the time of entering into Higher Judicial Service officer has following Items/investments:-
- (i)Ornaments of his wife made of gold 200 gms. Approx present value Rs.5,68,400/-.
- (ii)500 gms. Silver approx present value Rs.21,075/-.
- (iii)Old Wagon R car No.-UP-16 H 6964 Model-2006.
- (iv)Honda Activa no. UP 32 CT 6114 (in name of his wife).

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2013-14 and 2014-15 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below.

- (2)In the financial year 2013-14, Sri Sunil Kumar's Gross Income from Salary is Rs.6,63,428/- from this amount Rs.2800/- against GIS, Rs.49,470/- against Income Tax, Rs.32,000/- against PPF, Rs.26100/- against PLIC. The balance of his Saving Bank Account(s) has enhanced for Rs.45,248/- in this year against the balance of previous year. As such, total deductions / repayment/ Savings/ investment is Rs.1,55,618/-. Thus a sum of Rs.5,07,810/- was therefore available with him to meet out the household expenditure of his family consisting of two members in the financial year 2014-15.
- (3) In the financial year 2014-15, Sri Sunil Kumar's Gross Income from Salary is Rs.13,31,015/- from this amount Rs.4800/- against GIS, Rs.1,48,486/- against CPF, Rs.1,68,369/- against Income Tax, Rs.5,000/- against PPF, Rs.26,100/- against PLIC. The balance of his Saving Bank Account(s) has enhanced for Rs.2,00,802/- in this year against the balance of previous year. As such, total deductions /repayment/Savings/investment is Rs.5,53,557/-. Thus a sum of Rs.7,77,458/- was therefore available with him to meet out the household expenditure of his family consisting of two

members in the financial year 2014-15.

The movable and immovable property statement for the financial years at the time of joining the Higher Judicial Service and financial year 2013-14 and 2014-15 has been sent by the officer vide his letter dated 19.8.2017 (flag 'A'). The property statements for at the time of joining the Higher Judicial Service was due to be submitted just after at the time of entering into Judicial Service and financial year 2013-14 and 2014-15 was due to be submitted in the financial year 2015-16 i.e. on or before 31.3.16. As such delay in submitting the aforesaid property statement from the part of the officer for which officer has regretted.

May, if approved, the statements of movable and immovable property at the time of joining the Higher Judicial Service and for the financial years 2013-14 (i.e. from 19.8.13 to 31.3.14) and 2014-15 of Sri Sunil Kumar-V, Additional District and Sessions Judge, Bijnor may kindly be laid before Hon'ble Mr Justice P.K.S.Baghel Administrative Judge, Bijnor Judgeship for His Lordship's kind perusal and orders?
