May Kindly see the letter, placed below at flag 'A', received from Sri Shivam Kumar, Civil Judge (Jr. Div.), Utraula- Balrampur, presently under training at Judicial Training and Research Institute, Lucknow by which he has requested for grant of permission to certify the application form and forward the same to Joint Registrar (Exams), Hon'ble High Court of Delhi and to grant him permission to appear in the Delhi Judicial Services (Pre.) Examination 2017.

In his letter, Sri Shivam has stated that he wants to appear in Delhi Judicial Service Examination 2017. He has further stated that as per notification, it is required that a government employee has to send his application from through the head of the department and last date for the duly filled and forwarded application form to reach the Hon'ble Court of Delhi 15.02.2108. He has, therefore, requested to certify the application form and forward the same to Joint Registrar (Exams), Hon'ble High Court of Delhi and also to grant him permission to appear in the aforesaid examination.

In this connection, it is submitted that the officer has joined the U.P. Nyayik Sewa on 27.07.2015. It is also to mention here that for the first part of his request i.e. to certify the application form and forward the same to Joint Registrar (Exams), Hon'ble High Court of Delhi, action has already been taken through this Court's letter no. 2095/ IV-4224/ Admin (A) dated 05.02.2018 and for the other part of his request i.e. to grant him permission to appear in the Delhi Judicial Service Examination 2017, It is desirable that he may be accorded permission to appear in the Delhi Judicial Services preliminary examination.2017, if the Court so desires. Permission to appear in such type of written examination may be accorded, but subject to the following conditions:-

1. Government work should not suffer in any way.
2. No preferential treatment will be given in the matter of leave, postings and transfer.
3. The permission can be withdrawn without notice if; it is found at any time that the government servant neglects his normal work or that public work suffers, in any way.
