May Kindly see the letter, placed below at flag 'A', received from Sushri Akanksha Mishra, Additional Civil Judge (Jr. Div), Mirzapur, in which she has requested to the Court to grant him permission to appear in the examination of Haryana Civil Service (Judicial Branch) Mains examination-2014.

In her letter, Sushri Akanksha Mishra has stated that she wants to appear Haryana Judicial Service Mains examination, tentatively in June. She has also enclosed the photocopy of admit card of preliminary examination and the revised result in which her roll no. is include. She has further stated that presently, she is undergoing training at JTRI, UP, Lucknow since 22-04-2015. She has therefore requested to the Court to grant him permission to appear in above mentioned examination.

In this connection it is submitted that the officer has joined the U. P. Nyayik Sewa vide Court's notification dated 16-04-2015. It appears that she has appeared in the preliminary examination of the Haryana Judicial Service before joining the U P Judicial Service. Now as she has joined the U. P. Judicial Service. Her request for grant of permission to appear in the mains examination of the aforesaid examination, ^{may be considered,} if the Court so desires. Permission to appear in such type of written examination may be accorded, but subject to the following conditions: -

- (1) Government work should not suffer in any way.
- (2) No preferential treatment will be given in the matter of leave, postings and transfer.
- (3) The permission can be withdrawn without notice if; it is found at any time that the government servant neglect her normal work or that public work suffers, in any way.

May, therefore, if approved by Hon'ble Mr. Justice Arvind Kumar Mishra-I, Administrative Judge, Mirzapur, permission be accorded to Sushri Akanksha Mishra, Additional Civil Judge (Jr. Div), Mirzapur to appear in the Haryana Civil Service (Judicial Branch) Mains examination, ^{2014,} subject to the conditions mentioned above?
