May Kindly see the letters, placed below at flags 'A' & 'B', received from Km. Akanksha Mishra, Additional Civil Judge (Jr. Div.), Mirzapur in which she has requested to the Court to grant her permission to appear in the Delhi Judicial Service (Pre) Examination, 2015.

In her letter dated 17.12.2015 (at flag 'B'), Km. Akanksha Mishra, by enclosing copy of 'Admit Card' of Delhi Judicial Service (Pre) Examination, 2015, has stated that she wants to appear in the Delhi Judicial Service Examination, 2015. She has, therefore, requested to the Court for grant her permission to appear in the aforesaid examination. When the aforesaid letter dated 17.12.2015 was submitted/received in Admin (A) section, that time the date of preliminary examination of the said examination was passed over. Thereafter she was asked vide Court's letter dated 27.01.2016 (at flag 'C') to intimate to the Court as to whether she had appeared in the preliminary examination of the aforesaid examination, in anticipation of Court's permission, so that further necessary action may be taken in the matter.

In reply of aforesaid Court's letter, Km. Akanksha Mishra has sent a letter dated 16.04.2016 (at flag 'A') in which she has stated that she had appeared in the Delhi Judicial Service Examination (Pre.) 2015 in anticipation of Hon'ble High Court's permission.

In this connection, it is submitted that the officer has joined the U.P.Nyayik Sewa on 21.04.2015. It is pertinent to mentioned here that as stated Km. As per facts & circumstances, it would be proper that she may be granted ex-post facto permission to appear in the preliminary examination of Delhi Judicial Service Examination, 2015.
