5(5) *Any Officer, whose assistance has been sought under sub-section (4), shall render all assistance to the Central Public Information Officer or State Public Information Officer, as the case may be, seeking his or her assistance and for the purposes of any contravention of the provisions of this Act, such other officer shall be treated as a Central Public Information Officer or State Public Information Officer, as the case may be.*

In the view of the above, kindly direct the official/Officer concerned to provide the desired information at point no. 1 and 2 as sought by the applicant in the said RTI application at the earliest, but not later than 03 days, so that the same may be provided to the applicant within the specified time of 30 days with the permission of Hon'ble the Chief Justice.







Letter No. A-72/2019 'Conf' dated 17.01.2019 of Sri Manvendra Singh, HJS, Senior Registrar, Lucknow Bench, Lucknow enclosing therewith photocopy of papers of letter No. 3789/I-2018 of the District Judge, Pilibhit sending therewith report in the matter of complaint dated nil alongwith enclosures made in the style of "Samast Nivasaigan Sahaswani Tola Purana Shahar, Thana Baradari Bareilly against Sri Ashgar Ali, Civil Judge (JD) Bisalpur, District Pilibhit, Hon'ble the Administrative Judge, Pilibhit has been pleased to pass the following order on 10.01.2019, as under :

" Perused the explanation submitted by Sri Asgar Ali. He has accepted this fact that criminal case No. 2613 of 2006, under Sections 147, 148, 353, 504, 506, 186, 189 & 225 IPC and Section 7 of the Criminal Law Amendment Act, Police Station Kotwali, District Bareilly was registered against him and after trial, he has been acquitted.

Likewise Criminal Case No. 2915 of 2006, under Sections 420 and 193 IPC, Police Station Kotwali, District Bareilly was registered against him and he has been acquitted in this crime also. According to his knowledge, no appeal or revision is pending before the Sessions Judge or High Court.

Section has to verify whether Sri Asgar Ali disclosed these facts while he appeared in examination of Civil Judge(Jr. Div) 2013 or not. On the other hand, the District Judge Polibhit has to verify whether judgment dated 18.04.2015 delivered in Criminal Case No. 2613 of 2006, under Sections 147, 148, 353, 504, 186, 189 & 225 IPC and Section 7 of the Criminal Law Amendment Act, Police Station Kotwali, District Bareilly and Criminal Case No. 2915 of 2006, under Sections 420 and 193 IPC, Police Station Kotwali, District Bareilly has been assailed before higher court or not.

The compliance report be submitted within a month."
