Subject:- Grant of Permission/ Issuance of 'Identity Certificate' to Sri Sushil Kumar Singh, Judicial Magistrate, Kasganj (Kashi Ram Nagar) for obtaining Passport.

Sir,

With reference to your endt. no. 1174/ XV/ Civil dated 10.06.2016 on the above subject, I have to say that Sri Sushil Kumar Singh, Judicial Magistrate, Kasganj (Kashi Ram Nagar) may kindly be informed that for obtaining passport, permission is not granted by the Court but 'Identity Certificate' as prescribed by the Passport office, is issued by the Court on such request. However, for issuance of 'Identity Certificate' to obtain passport, Sri Singh may kindly be asked to intimate about his dependent family members as on date and to submit following **declarations as per Section 6 (2) of the Passports Act, 1967, as well as following informations/ declarations on an 'Affidavit':-**

- (a) that the applicant is a citizen of India;
- (b) that the applicant may not, or is not likely to, engage outside India in activities prejudicial to the sovereignty and integrity of India;
- (c) that the departure of the applicant from India may not, or is not likely to, be detrimental to the security of India;
- (d) that the presence of the applicant outside India may not, or is not likely to, prejudice the friendly relations of India with any foreign country;
- (e) that the applicant has, at any time during the period of five years immediately preceding the date of his application, not being convicted by a court in India for any offence involving moral turpitude and sentenced in respect thereof to imprisonment for not less than two years;
- (f) that proceedings in respect of any offence alleged to have not been committed by the applicant are pending before a criminal court in India;
- (g) that a warrant or summons for the appearance, or a warrant for the arrest, of the applicant has not been issued by a court under any law for the time being in force or that an order prohibiting the departure from India of the applicant has not been made by any such court;
- (h) that the applicant has not been repatriated.
