May kindly see the office note, placed below at flag 'X', dated 23.10.2017 received from Accounts (B-1) section through which the section has forwarded the letters (flagged 'A' & 'A-1') of Sri Sushil Kumar Singh, Civil Judge (Jr. Div.), Jalalabad, Shahjahanpur regarding grant of permission to reside at District Headquarter Shahjahanpur i.e. to leave the place of posting every day.

In his letters, Sri Singh has stated that he has been posted at Jalalabad, Shahjahanpur as Civil Judge (Jr. Div.), vide Hon'ble Court's Notification no. 1514/ Admin. (services)/ 2017 on 07.07.2017. He has further stated that there is no government quarter is available to reside at Jalalabad, Shahjahanpur and he has a three months old son, who often faces illness and there is no medical treatment facility is available at Jalalabad town, Shahjahanpur. Earlier, the District Judge, Shahjahanpur was requested to submit his reports/ comments vide Hon'ble Court's letter dated 04.10.2017 by Accounts B-1 section. In reply of which the District Judge has submitted that there is no accomodation for Judicial Officer, is available at Outlying Court, Jalalabad, Shahjahanpur. Therefore, the officar has requested the Court to grant him permission to reside at Shahjahanpur headquarter.

In this connection, it is submitted that in the instant case, the officer has requested to reside at Shahjahanpur Headquarter i.e. to travel daily from the headquarter to outlying Court Jalalabad keeping in view all the above circumstances. Acceptance of his request to reside at Shahjahanpur and moving to and fro from Shahjahanpur every day i.e. to leave the place of posting every day, is on the discretion of the Hon'ble Administrative Judge of the judgship as per prevailing practice.

May, therefore, if approved, the file may be laid before Hon'ble Mrs. Justice Sunita Agarwal, Administrative Judge, Shahjahanpur Judgship for kind perusal and orders and if Her Lordship approves:-

(a) Sri Sushil Kumar Singh, Civil Judge (Jr. Div.), Jalalabad, Shahjahanpur may be granted permission to reside at Shahjahanpur Headquarter i.e. to leave the place of posting every day as there is no government accomodation is available in the outlying Court Jalalabad, as requested?

Or

(b) to pass any other order which Her Lordship deems fit and proper ?
