Sri Sushil Kumar Singh, Civil Judge, Jr. Div., Jalalabad, Shahjahanpur, has submitted vide his letter dated 18.09.2017 that he has been posted at Jalalabad, in Shahjahanpur as Civil Judge, (Jr. Div.), vide Hon'ble Court's Notification NO. 1514/Admin. (Services)/2017 on 07.07.2017. There is no government accommodation available to reside at Jalalabad, Shahjahanpur. He has a three year old son, who often faces illness, needs regular checkups and treatment but there is no treatment facility available in Jalalabad town, Shahjahanpur. In the last Sri Singh has requested the Court to grant him permission to reside in Shahjahanpur headquarter.

The District Judge, Shahjahanpur was requested vide Court's letter No. 14644/Admin.(B-I) Section dated 04.10.2017 to submit his reports/comments in the above matter. 
