In this connection, it is submitted that Sri Rajan Kumar Gond in his letter dated 10.07.2018 (at **flag 'A'**) has stated that he wants to appear in preliminary examination of UPPSC P.C.S. Examination 2018 with the permission of this Court. He has, therefore requested to grant him permission to appear in the aforesaid examination.

In this connection, it is submitted that the officer has joined U.P. Nyayik Sewa on 09.02.2016. It is desirable that he may be accorded permission to appear in the preliminary examination of UPPSC P.C.S. Examination 2018, at present, if the Court so desires. Permission to appear in such type of written examination may be accorded, but subject to the following conditions:

- (1) Government work should not suffer in any way.
- (2) No preferential treatment will be given in the matter of leave, postings and transfer.
- (3) The permission can be withdrawn without notice if; it is found at any time that the government servant neglect his normal work or that public work suffers, in any way.

**A** May therefore, if approved by Hon'ble Mr. Justice Anil Kumar, Administrative Judge, Azamgarh Judgeship, permission be accorded to Sri Rajan Kumar Gond, Civil Judge (Jr. Div.), Azamgarh to appear in preliminary examination of UPPSC P.C.S. Examination 2018, as requested, subject to the conditions mentioned above?
