2. यूरोपीय जाति के उम्मीदवारों की स्वास्थ्य परीक्षा करने के लिए आयु कद और छाती की चौड़ाई का पारस्परिक सम्बन्ध प्रदर्शित करने में निम्नलिखित तालिका उदाहरण स्वरूप उपयोग में लानी चाहिए। यह भारतीय मिश्रित जातियों के सम्बन्ध में

3. उम्मीदवार की लम्बाई इस प्रकार नापी जायेगी। वह अपने जूते उतारेगा और मापदण्ड(Standard) के सामने अपने दोनों पैर मिलाकर तथा एड़ियों के बल खड़ा होगा। न कि अंगूठों या पैर में बाहर की ओर देकर खड़ा होगा। वह स्वामाविक रूप से सीधा खड़ा होगा और एड़िया, पिडलियां, चूतड़ और कंधे मापदण्ड को स्पर्श करें ठड़ड़ी को इस प्रकार नीचे किया जायेगा कि सिर के धरातल का सबसे ऊँचा भाग मापदण्ड के हारिजंटल—बार के नीचे लगा रहे और नं0 को माप इन्चों में और इन्च के चौथाई भाग में लिखी जायेगी। इण्डियन पुलिस फोर्स के लिए कम से कम 5 फुट 4 इंच की लम्बाई आवश्यक है, लेकिन अन्य विभागों में लम्बाई की कोई निर्धारित सीमा नहीं रखी गई है।

4. उम्मीदवार की छाती इस प्रकार नापी जायेगी। वह पांव मिलाकर अपने सिर के ऊपर दोनो बाहो को उठाकर सीधा खड़ा किया जायेगा फीता उसकी छाती के चारों ओर इस प्रकार रखा जायगा कि उसका ऊपरी सिरा कन्धे की हड़डी के पीछे की ओर से निम्न कोणों के और उसका नीचे का सिरा सामने स्तनो की ढपेनी (Nipples) के ऊपरी भागों को छूता रहे। तब बांहें नीचे की जायेगी तािक वे ढीले रूप में बगल की ओर लटकी रहे और इस बात का ध्यान रखा जायेगा कि कन्धे ऊपर या नीचे की ओर न किये जाये , जिससे फीता अपनी जगह से इघर उघर न हो। इसके बाद उम्मीदवार को को कई बार गहरी साँस लेने के लिए आदेश किया जायेगा ओर सीने का अधिक से अधिक विस्तार सावधानी से लिखा जायेगा। कम से कम और अधिक से माप इन्चों में लिखी जायेगी। 33–35–34–36–1/2 नापों को लिखने में 1/2 इन्च से कम भाग छोड़ देना चाहिए।

5. उम्मीदवार की तौल भी ली जायेगी और वजन पाउन्डो में लिखा जायेगा। एक पाउन्ड से कम भाग नहीं लिखा जायेगा।

जब कोई दोष पाया जाय प्रमाण पत्र पर उसका उल्लेख कर देना चाहिए और स्वास्थ्य परीक्षक को अपनी अनुमति देना चाहिए कि इसके कारण उस कार्य को सुचारू रूप से सम्पादन करने में, जो उम्मीदवार को करना पड़ेगा, कोई बाधा पड़ने की सम्भावना है कि नहीं। यदि उसकी अवस्था आपरेशन करने से सुधर सकती है तो उसका उल्लेख कर देना चाहिए।

At the start, it is worth mentioning that the Indian law Institute, was founded in 1956, in New Delhi, primarily with the objective of promoting and conducting legal research, education and training. Hon'ble Chief Justice of India is the ex officio President of the Institute. The Law Minister of Government of India & the Attorney-General for India are its ex officio Vice Presidents. Judges of the Hon'ble Supreme Court of India and High Courts, prominent lawyers are represented in the Governing Council of the Institute.
- That the said diploma course in Securities and Banking Laws, was entirely, an evening course, designed for practicing lawyers, with only a bi-weekly / tri-weekly class structure.


