May kindly see the letter, placed below at flag '1', received from Sushri Madhulika Choudhary, Additional District & Sessions Judge, Budaun by which she has submitted supplementary details/ papers in connection with information about purchase of new Creta 1.6 CRDI car in compliance of Court's order.

In this connection, it is submitted that earlier the officer has informed about purchase of new Creta 1.6 CRDI car for Rs. 14,33,083/- through her letters dated 23.09.2016, 01.12.2016 & 13.02.2017 (flagged 'A', 'A-1' & 'A-2'). The matter was submitted before Hon'ble Mr. Justice Manoj Misra, vide office note dated 07.03.2017 (flagged '2') upon which His Lordship has been pleased to pass the following order:

**"The officer may be asked to provide proof of income of her real sister Neelam Chaudhary from whom she has allegedly taken Rs. 2,80,000/-. The officer must also give details of the registration amount paid because the invoice only indicates temporary registration. The source of payment of registration amount should also be explained"**

The order was communicated vide Court's letter dated 31.07.2017 (flagged '3'). Thus, in reply of the Court's letter dated 31.07.2017, Sushri Madhulika Choudhary, vide her letter dated 04.09.2017 at flag '1', has stated that she has paid the sum of Rs. 1,10,922/- along with a fine of Rs. 11,093/- through cash on 21.03.2016 at ARTO Dehradun towards registration of the said car. Out of Rs. 1,50,000/-, Rs. 1,22,085/- has been paid by her through cash at ARTO, Dehradun for registration of the the said car and the remaining amount was spent by her for personal use. The source of payment of Registration amount is salary. Copy of passbook indicating the relevant entry is at flag '4' & certificate issued by Tax Registration Officer indicating the amount of Rs. 1,10,922/- and a late fee of Rs. 11,093/- is at flag '5'. The officer has also enclosed copy of ITR of the year 2015-16 (flagged '6') along with latest Income Certificate of her sister Ms. Neelam Chaudhary <sup>Advocate,</sup> issued by the office of SDM, Mussorie.

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Manoj Misra for His Lordship's kind perusal & further order for acceptance of information about purchase of a new Creta 1.6 CRDI car now?
