WHEREAS on consideration of enquiry report dated 13.04.2004 in V.B.Enquiry No. 18/2003 submitted by Sri Shashank Shekhar, O.S.D. (Enquiry), High Court Allahabad against Sri Arun Kumar Saxena, the then, Additional District & Sessions Judge, Saharanpur now posted as Special Judge (S.C./S.T. Act), Hamirpur, the Court has decided to initiate departmental enquiry against him.
