May kindly see the application at flag 'A' of Sri Asun Kumar Saxena, Additional District and Sessions Judge, Fatehpur duly forwarded by the District Judge, Fatehpur for grant of personal pay under Voluntary Family Planning Programme in terms of G.O. No. Pa. Ka.-4601/16-11-79-9/155/79 dated 23.2.80.

According to papers received from Sri Saxena along with his application and the papers on the record of the case, the details of the claim are as under:-

- ① His date of birth is 29.9.1956.
- ② His present age is 43 years and 2 months.
- ③ He joined service on 15.12.98.
- ④ He has two children only (vide declaration at flag 'B')
- ⑤ The age of his youngest child is 14 years and one month. Her date of birth is 17.11.1985 (vide copy of birth certificate at flag 'C')
- ⑥ His wife is alive and she is not a government servant (vide declaration at flag 'B').
- ⑦ Neither disciplinary proceedings have been started against him nor he has been suspended in connection with such proceedings. He has also not been punished by stoppage of increments or any other punishment. (vide report of S.O. confidential at flag 'D').
- ⑧ He has not been granted the benefit of one increment under Rule 12 of the U.P. Government servants (special provisions regarding Family Planning) Rules, 1976 (vide declaration at flag 'E').
- ⑨ He has furnished the declarations as required by G.O. No. 1683/16-11-80-9/155/79 dated May 26, 1980 and G.O. No. 2667/16-11-80-9/155/79 dated June 11, 1980 (flagged 'B')

In the light of the relevant G.O.s. Sri Asun Kumar Saxena, Additional District & Sessions Judge, Fatehpur fulfills all the conditions laid down
