1. Consequent upon the recommendations of the High Court of Delhi, the Lt. Governor of the National Capital Territory of Delhi, being the Appointing Authority, is pleased to offer, in terms of Rule 5 of Delhi Higher Judicial Service Rules, 1970, to Mr. Mohd. Farrukh an appointment to the Delhi Higher Judicial Service on probation for a period of two years in accordance in terms of rule 12 of Delhi Higher Judicial Service Rules, 1970 on the following terms and conditions:
 - a. The post carries the time-scale of pay of members of the Delhi Higher Judicial Service ₹51550-1230-58930-1380-63070 plus allowances as are admissible to officers working under the Government of the National Capital Territory of Delhi.
 - b. The appointment shall be subject to provisions of the Delhi Higher Judicial Service Rules, 1970 and other orders/instructions as may be applicable to the officers of the Delhi Higher Judicial Service from time to time.
 - c. The age of superannuation to the aforesaid post shall be subject to other provisions of relevant rules or orders in force from time to time.
 - d. Unless the said Mr. Mohd. Farrukh is confirmed, his service shall be liable to be terminated by one month notice in writing or by payment of one month salary in lieu of the period of notice.
 - e. No TA/DA shall be admissible for joining the appointment.
 - f. This offer of appointment is subject to his being declared medically fit in accordance with the standards prescribed for the IAS, as required by Rule 26 of Delhi Higher Judicial Service Rules, 1970.
 - g. This offer of appointment is further subject to verification of his character and antecedents from the concerned police authorities and verification of caste certificate, if applicable.

Farrukh is hereby advised that in case he is willing to accept the offer of appointment to the Delhi Higher Judicial Service on the terms and conditions mentioned above, he should reach to the Lt.
