May kindly see below placed letter dated 12.10.2015 along with resignation letter dated 05.10.2015(at flag 'A') of Sri Mohd. Farrukh, Additional District & Sessions Judge, Farrukhabad duly forwarded by the Director, JTRI, Lucknow, U.P regarding his resignation from U.P.Higher Judicial Services.

Vide aforesaid letter Sri Mohd. Farrukh has informed that he has been declared successful in Delhi Higher Judicial Services Examination-2014 and vide Delhi Government's Notification No. F.6/10/2015-Judl./Suptlaw/ dated 24.09.2015 his appointment in Delhi H.J.S has been confirmed.

Further, he has stated that in order to be able to join the new post, his resignation from U.P. Higher Judicial Services has become necessary thus he wants to resign from the present post of Additional District & Sessions Judge, Farrukhabad with immediate effect. He has also requested to waive his notice period of three months, which is in general supposed to precede one's resignation.

In this context it is submitted that as per report obtained from Confidential 'A' section(placed at flag 'B'), Sri Mohd. Farrukh recently entered into U.P. Higher Judicial Services(i.e on 06.07.2015) and has not yet been confirmed in UPHJS. Further, as per general practice in the case of a temporary Government servant, either the Government may terminate his services after three month's notice or pay in lieu thereof, or the Government servant may terminate his services after giving three month's notice. In instant matter, since the appointing authority is the Government of U.P, request regarding resignation/waiving prescribed notice period has to be sent to Government for necessary orders.

Presently, there is no departmental/vigilance enquiry pending against Sri Mohd. Farrukh, Additional District & Sessions Judge, Farrukhabad.

In the view of above submitted facts and information, if approved by Learned Registrar General, the matter may be placed before Hon'ble the Chief Justice for His Lordship's kind perusal and order to the effect that said resignation letter dated 05.10.2015(placed at flag 'A') of Sri Mohd. Farrukh, Additional District & Sessions Judge, Farrukhabad along with other relevant information may be sent to the Special Secretary, Appointment Section-4, Government of U.P, Lucknow for further necessary action in instant matter ? Also, a copy of same may be forwarded to the District Judge, Farrukhabad and to Sri Mohd. Farrukh, Additional District & Sessions Judge, Farrukhabad for information and necessary action ?
