May like to peruse the resignation letter dated 05.10.2015, placed below, of Sri Mohd. Farrukh, Additional District & Sessions Judge, Farrukhabad moved through District & Sessions Judge, Ghaziabad (as the officer is undergoing training at Ghaziabad).

It is submitted by the officer concerned that he has been appointment vide Government Notification dated 26.06.2015, appointed in the U.P. Higher Judicial Service vide Notification of this Hon'ble Court dated 02.07.2015 and posted as Additional District & Sessions Judge, Farrukhabad. He joined the service on 6<sup>th</sup> July, 2015.

The officer has further stated that he is selected in Delhi Judicial Service, the examination of which was conducted by the Hon'ble Delhi High Court in three phases. The appointment has been effected vide notification dated 24<sup>th</sup> September, 2015 and he intends to accept the same and therefore his resignation from the post of Additional District & Sessions Judge is deemed necessary (copy of notification is enclosed).

He has tendered his resignation with immediate effect and the same is stated as absolute and unqualified.

The officer concerned has submitted that the three months notice period which ought to precede his resignation may kindly be waived off and dispensed with. He, therefore, has requested that his resignation letter may kindly be placed before the Hon'ble Court for kind consideration and forward the same to the appointing authority i.e. Hon'ble the Governor of the State of U.P. for its acceptance.

In this connection it may be submitted that the execution of the resignations of the Judicial Officer does not fall within the work area of Selection & Appointment Cell and a copy of the said resignation has already been marked to the Sr. Registrar (Budget) and Registrar (Cf.) for taking necessary action. The resignation of the officer concerned may be sent to the Joint Registrar (Services) for taking into consideration while determination of vacancies for the future HJS Examinations, if the same is accepted and the officer concerned leaves his charges. A copy of Government Notification dated 26<sup>th</sup> June, 2015 through which the Government had notified the appointment of the candidates/officers of U.P. Higher Judicial Service, 2014 is placed below, wherein the name of the officer concerned finds place at **Sl. 54**.
