This is in reference to your letter no 7473/IV-4333/ Admin. (A-4)/ dated 07.06.2017 wherein your goodself had asked for certain information with respect to my letter no 388/XV/6A dated 05.05.2017 for granting permission to pursue my LL.M. Course (Correspondence). I this respect i shall state that i had taken the admission in LL.M. course in September, 2016 at the Directorate of Distance Education- Kurukshetra University for 2016-2018 batch. The applicant was inducted at the Uttar Pradesh Judicial Service on 18.01.2017 which was ahead of his taking admission in LL.M.course. The examination date sheet pertaining to 1st year LL.M. was issued by the University sometimes in May, 2017 and thereafter the applicant had written a letter to Hon'ble High Court seeking permission to appear in 1st year LL.M. course and further in anticipation of grant of permission had appeared in LL.M. 1st year examination which was scheduled in May-June, 2017.

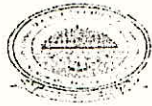
