Request

May kindly see the letter, placed below at flag 'A', received from Sri Manas Vatsa, Judicial Magistrate, Sitapur regarding grant of permission to appear in Delhi Judicial Services Mains Examination-2017.

In this connection, it is submitted that Sri Manas Vatsa in his letter dated 10.07.2018 (at flag 'A') has stated that he has been permitted to participate in Preliminary examination of Delhi Judicial Services Examination-2017 through Court's letter dated 7599/IV-4365/Admin(A-4) dated 17.05.2018 and has qualified the aforesaid preliminary examination vide result dated 04.06.2018 declared by Hon'ble High Court, Delhi. He has, therefore requested to grant him permission to appear in Delhi Judicial Services Mains Examination-2017 which is scheduled to be held on 13.10.2018 & 14.10.2018 (tentative dates).

In this connection, it is further submitted that the officer has joined U.P. Nyayik Sewa on 08.02.2017. Earlier, vide order dated 19.02.2018 (at flag 'X') of Hon'ble the Administrative Judge, Sitapur, he had already been granted permission to appear in preliminary examination of Delhi Judicial Services Examination-2017 and now as requested by him, it is desirable that he may be accorded permission to appear in the Mains of the said examination, as he has qualified the preliminary examination. Permission to appear in such type of written examination may be accorded, but subject to the following conditions:

1. Government work should not suffer in any way.
2. No preferential treatment will be given in the matter of leave, postings and transfer.
3. The permission can be withdrawn without notice if, it is found at any time that the government servant neglect his normal work or that public work suffers, in any way.

May therefore, if approved by Hon'ble Mr. Justice K.N.Bajpayee, Administrative Judge, Sitapur Judgeship, permission be accorded to Sri Manas Vatsa, Judicial Magistrate, Sitapur to appear in Mains Examination of Delhi Judicial Services Mains Examination-2017, as requested, subject to the conditions mentioned above?
