May kindly see the letter, placed below at **flag 'A'**, received from Sri Ravi Kumar Sagar, Additional Civil Judge (Jr. Div.), Rampur regarding grant of permission to appear in Uttar Pradesh Civil Services Examination 2018.

In this connection, it is submitted that Sri Ravi Kumar Sagar in his letter dated 25.07.2018 (at **flag 'A'**) has stated that he has joined the U.P. State Judicial Services on 15th March 2017 as Additional Civil Judge (Jr. Div.) at Rampur and wants to appear in preliminary part of the U.P. Civil Services Examination 2018 to be conducted by UPPSC to be held on 19.08.2018. He has also enclosed photocopy of examination form of U.P. Civil services (Pre) examination-2018 (at **flag 'B'**). He has, therefore requested to grant him permission to appear in the said examination, it will not affect his normal work as Judicial officer for this act of kind favour.

In this connection, it is submitted that the officer has joined U.P. Nyayik Sewa on 15.03.2017. Preliminary examination of UPPSC Civil Services Examination 2018, which was earlier scheduled to be held on 19.08.2018 (postponed) would now be held on 28.10.2018 (notification is at **flag 'X'**). It is desirable that he may be accorded permission to appear in the preliminary examination of UPPSC Civil Services Examination 2018, at present, if the Court so desires. Permission to appear in such type of written examination may be accorded, but subject to the following conditions:

1. Government work should not suffer in any way.
2. No preferential treatment will be given in the matter of leave, postings and transfer.
3. The permission can be withdrawn without notice if; it is found at any time that the government servant neglect his normal work or that public work suffers, in any way.

May therefore, if approved by Hon'ble Mr. Justice Shashi Kant, Administrative Judge, Rampur Judgeship, permission be accorded to Sri Ravi Kumar Sagar, Additional Civil Judge (Jr. Div.), Rampur to appear in preliminary examination of UPPSC Civil Services Examination 2018, as requested, subject to the conditions mentioned above?
