महोदय,

ससम्मान निवेदन है कि आपके द्वारा प्रेषित पत्रांक संख्या 9388/IV-3915/एडमिन (ए) इलाहाबाद दिनांकित 15.6.2016, प्रार्थी को रेसिस के बाद आने पर दिनांक 23.6.2016 को प्राप्त हुआ, के सम्बन्ध में प्रार्थी द्वारा सन 2010-11 से लगायत सन 2015-16 वित्तीय वर्ष से सम्बन्धित मेरे द्वारा सैलरी से प्राप्त कुल आय एवम खर्च से सम्बन्धित विवरण माननीय महोदय के अवलोकनार्थ हेतु प्रेषित किया जा रहा है। उपरोक्त के सम्बन्ध में मुझे यह कहना है कि दिनांक 19.4.2010 को प्रार्थी माननीय उच्च न्यायालय इलाहाबाद के आदेश के क्रम में सिविल जज(जूनियर डिवीजन) के पद पर पदस्थापित हुआ। मुझे वित्तीय वर्ष 2012-13, 2014-15 तथा 2016-17 में कुल आय एवम खर्च वास्ते चल एवम अचल सम्पत्ति के सम्बन्ध में विवरण प्रस्तुत करना था। प्रार्थी द्वारा अप्रैल के प्रथम सप्ताह में दिनांक 5 अप्रैल सन 2012 को मारुति सुजुकी ए-स्टार चार पहिया वाहन जरिये लोन क्रय किया था यद्यपि कि उपरोक्त गाडी से सम्बन्धित विवरण हमारे पास थे परन्तु क्योंकि उक्त गाडी मेरे ससुर द्वारा दान में देने हेतु स्वीकृति प्रदान की गयी थी तथा गाडी लेते समय मैं उनसे स्वीकृति प्रमाण पत्र प्राप्त नहीं कर पाया था। मेरे ससुर विदेश में सेवा बतौर Captain in Shipping Corporation में कार्यरत है। अधिकांश समय वह बाहर विदेश में रहते है तथा इस समय भी वे विदेश में ही है। यही कारण है कि सन 2012-13 वित्तीय वर्ष का विवरण मैं प्रस्तुत नहीं कर सका था क्योंकि मैं यह समझता रहा कि स्वीकृति प्रमाण पत्र लेने के बाद ही प्रस्तुत करूं। इसके बाद सन् 2013 में 21 मई को वाहन सं० यू०पी० 53 बीएफ 3888 जो मैंने अपने स्थायी निवास की आवश्यकता को देखते हुए क्रय की थी, उसके संबंध में सूचना इसलिए प्रेषित नहीं कर सका था कि पूर्व में दान द्वारा प्राप्त वाहन सं० यू०पी० 66 के 6003 के संबंध में दान स्वीकृति प्रमाण पत्र के अभाव में सन् 2012-13 का ही प्रेषित नहीं कर सका था। मेरे
