May Kindly see the letter, placed below at flag 'A', received from Smt. Sonali Ratna, Judicial Magistrate, Bareilly by which she has requested for grant of permission to complete the endorsement given at the end of application form and forward the same to Joint Registrar (Exams), Hon'ble High Court of Delhi, Sher Shah Road, New Delhi and to grant her permission to appear in the Delhi Judicial Services (Pre.) Examination 2018.

In her letter, Smt. Sonali has stated that she wants to appear in Delhi Judicial Service Examination 2018 and she has filled the online application form of the said examination, which is scheduled to be held on 13.01.2019. She has further stated that as per the instructions, it is required that a government employee has to send her application from through the head of the department and forward the same to Joint Registrar (Exams), Delhi High Court through proper channel and last date for the duly filled and forwarded application form to reach the Hon'ble Court of Delhi 12.12.2018. She has, therefore, requested to complete the endorsement given at the end of application form and forward the same to Joint Registrar (Exams), Hon'ble High Court of Delhi, New Delhi and also to grant her permission to appear in the aforesaid examination.

In this connection, it is submitted that the officer has joined the U.P. Nyayik Sewa on 13.09.2018. It is also to mention here that for the first part of her request i.e. to certify the application form and forward the same to Joint Registrar (Exams), Hon'ble High Court of Delhi, action has already been taken through this Court's letter no. 17463/ IV-4631/ Admin (A) dated 04.12.2018 and for the other part of her request i.e. to grant her permission to appear in the Delhi Judicial Service (Preliminary) Examination 2018, It is desirable that she may be accorded permission to appear in the Delhi Judicial Services preliminary examination 2018, if the Court so desires. Permission to appear in such type of written examination may be accorded, but subject to the following conditions:-

1. Government work should not suffer in any way.
2. No preferential treatment will be given in the matter of leave, postings and transfer.
3. The permission can be withdrawn without notice if; it is found at any time that the government servant neglects her normal work or that public work suffers, in any way.

May, therefore, if approved, the file may be laid before Hon'ble Mr. Justice Abhinav Upadhy, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders to the effect that permission be accorded to Smt. Sonali Ratna, Judicial Magistrate, Bareilly to appear in the Delhi Judicial Service (Pre.) Examination 2018, as requested, subject to the conditions mentioned above?
