In this regard it is submitted that the officer has purchased a Maruti car 800 D.X. A.C. for sum of Rs. 2,82,000/- . He has taken Rs. 80000/- as motor car advance from Honble High Court and taken loan Rs. 1,82,000/- from ~~S.B.I. Main Branch~~ Orai which is payment of loan taken from bank in 84 instalment, each instalment amount Rs 3205/- p.m. vide his letter dated 22-5-2002 which is at flag 'x'. The officer has paid Rs 9960/- motor car Advance shown in deduction in movable property for the calendar year 2003 but he has not mentioned paid Rs 38460/- loan S.B.I. in ~~movable property~~ for the calendar year 2003 and he has not mentioned some loan in column no 7 in movable property for the year 2003 as required by the court. From the above calculation it appears that total deduction + deposits + savings for the calendar year 2003 comes Rs 1,72,200/- and gross income of salary Rs. 3,87,288/- . Thus only Rs 2,15,088/- is left with the officer out of his salary to manage his annual expenses <sup>having</sup> 5 members of his family <sup>out of</sup> which all the two sons & one daughter appears to be school going. He also maintains a Maruti car.

In this regard it is submitted that the statement of movable and immovable properties for the calendar year 2002 (at flag 'A') and the same has already been seen by Honble Mr. Justice Ashok Bhusan, Administrative Judge, Jalgaon at Orai Judgeship on 1-9-2003 vide office note dated 26-8-2003 at flag 'B'.
