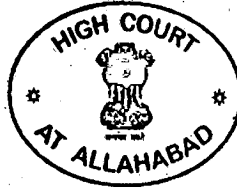

May kindly see the application/ letters at flags 'A' & 'A-1', received from Sri Mukhtar Ahmad, District & Sessions Judge, Fatehpur, by which he has requested the Court for issuance of 'Identity Certificate' for obtaining Passport.

In his letters, Sri Mukhtar Ahmad has stated that he along with his wife Smt. Shahjahan want to go on Haj pilgrimage in 2011, for which a passport is required. Passport authority has required an Identity Certificate in duplicate on original stationery on a prescribed proforma which has been enclosed by him. He has also submitted that:-

1. There will be no possibility of arising embarrassing position of the Government of India or U.P. from his foreign visit.
2. No such request was ever refused to him as he is applying for the same first time.
3. He has not visited any foreign country earlier.

He has therefore, requested that he may be issued the requisite Identity Certificate as required by the Passport authority, so that he may get passport.

In this connection, it is submitted that 'No-objection Certificate' for obtaining a Passport may be issued to the officers in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 (flagged 'B'). It is further submitted that as per reports, placed below, no vigilance/ departmental enquiry is pending against Sri Mukhtar Ahmad. Now, as per orders of the Court 'No-objection Certificates' are being issued to judicial officers for obtaining Passport.
