

May kindly see the application/letter dated 28-8-09 of Sri Mukhtar Ahmed District Judge, Faizabad regarding grant of personal pay under voluntary family planning programme placed below at play 'A'?

It may be recalled that Sri Mukhtar Ahmed had earlier applied for grant of personal pay under voluntary family planning programme through his application dated 17-7-2009 (flagged^b) but he did not submit declarations. Therefore a court's letter dated 22-8-09 (flagged^b) alongwith format of declaration (two) regarding grant of personal pay under voluntary family planning programme was sent to the ~~to~~ Sri Mukhtar Ahmed, District Judge, Faizabad for completing the formalities. Now Sri Mukhtar Ahmed has submitted declarations on prescribed format alongwith attested copies of certificates through this aforesaid letter dated 28-08-09 to this Court for necessary action.

According to papers received from Sri Mukhtar Ahmed dated 17-7-09 and 28-8-09 and papers available on this instant personal file the details of the claim are as under:

- 1- His date of birth is 04-10-1956
- 2- His present age is 52 years 10 months 23 days
- 3- He joined the U.P Higher judicial service on 15-12-1992

- 4- He has two children vide declaration at flag 'B'
- 5- The age of this youngest child is 11 years 23 days and the date of birth is 05-8-1998
Vide Scholar's transfer certificate issued by Principal, Gyansthal Public School, Mhowa.
A attested photocopy of certificate is at flag 'D'
- 6- He has not got the personal pay under voluntary family planning programme vide declaration at flag 'C'
- 7- His wife is alive. She is not a government servant and she is not getting said benefit
Vide declaration at flag 'B'
- 8- Neither any departmental enquiry is pending against Sri Mukhtar Ahmad District Judge, Fethpur nor he has been banished by stoppage of increment and he has not been suspended in connection with such enquiry as reported by S.O confidential 'A' section at flag 'E'

Sri Mukhtar Ahmad, District Judge,
Fethpur has fulfilled all the conditions
as laid down in the aforesaid G.Os
for sanction of personal pay under
Voluntary family planning programme
equal to one increment with effect from

05-8-2008 when he become entitled
to the benefit on attaining the age of
40 years and his youngest child com-
pleted 10 years of age being his date of
birth 05-8-1998.

The file may therefore kindly be
laid before Hon'ble Mr Justice S.R. Alam
for His Lordship kind perusal and
order to sanction personal pay under
Voluntary family planning programme
equal to one increment with effect
from 05-8-2008 to Sri Mukhtar
Ahmad, District Judge, Fatehpur and
His Lordship may also be requested
to sign draft sanction order placed
below at the place cross marked with
red.
