May kindly see the application / letter dated 28-8-09 of Sri Mukhtar Ahmad District Judge, Fatehpur regarding grant of personal pay under voluntary family planning programme placed below at 'A'

It may be recalled that Sri Mukhtar Ahmad had earlier applied for grant of personal pay under voluntary family planning programme through his application dated 17-7-2009 (flagged X) but he did not submit declarations. Therefore a court's letter dated 22-8-09 (flagged X) along with format of declaration (two) regarding grant of personal pay under voluntary family planning programme was sent to the Sri Mukhtar Ahmad, District Judge Fatehpur for completing the formalities. Now Sri Mukhtar Ahmad has submitted declarations in prescribed format along with attached copies of certificates through his aforesaid letter dated 28-08-09 to this Court for necessary action.

According to papers received from Sri Mukhtar Ahmad dated 17.7.09 and 28.8.09 and papers available on this instant personal misc file the details of the claim are as under

- 1- His date of birth is 04-10-1956
- 2- His present age is 52 years 10 months 23 days
- 3- He joined the U.P Higher Judicial Service on 15-12-1998

4- He has two children vide declaration at page 'B'

5- The age of his youngest child is 11 years 23 days and his date of birth is 05-8-1998 vide Scholar's transfer Certificate issued by Principal, Cyonathali Public School, Mhoba. Attached photocopy of Certificate is at page 'D'

6- He has not got the personal pay under voluntary family planning programme vide declaration at page 'C'

7- His wife is alive. She is not a government servant and she is not getting said benefit vide declaration at page 'B'

8- Neither any departmental enquiry is pending against Sri Mukhtar Ahmad District Judge, Fatehpur nor he has been punished by stoppage of increment and he has not been suspended in connection with such enquiry as reported by S.O Confidential 'A' section at page 'E'

On terms of G.O NO. Pa. Ka 1683/16-11-80-9 / 155/79 dated 26.5.1980 and G.O NO. Pa. Ka 2667/16-11-80-9 / 155/79 dated 11-6-1980 required declarations have been furnished by him and same are at page 'B' and 'C'

In this connection it is submitted that Sri Mukhtar Ahmad, District Judge, Fatehpur has fulfilled all the conditions as laid down in the aforesaid G.Os for sanction of personal pay under voluntary family planning programme equal to one increment with effect from


05-8-2008 when he became entitled to the benefit on attaining the age of 40 years and his youngest child completed 10 years of age being his date of birth 05-8-1998.

The file may therefore kindly be laid before Honble Mr Justice S.R. Alam for His Lordship kind perusal and order to sanction personal pay under Voluntary family planning programme equal to one increment with effect from 05-8-2008 to Sri Mukhtar Ahmad, District Judge, Fatehpur and His Lordship may also be requested to sign draft sanction order placed below at the place cross marked with red.
