Note:- It is pertinent to mention here that the aforesaid car has been purchased by the officer in the name of his son Mr. Ashutosh Ojha. He has paid whole amount of the above vehicle although in the car loan for purchase of the vehicle his son is shown as co-borrower but loan is being repaid by the officer. By clubbing all the amount as at (b),(c) & (d) above, Rs. 3,84,852/- is debited from his SB A/C. (copy of passbook is at flag 'F').
