May kindly see the letter, placed below at flag 'A' received from Sri Anil Kumar Ojha, Special Secretary, Judicial and Additional L.R., Govt. of U.P., Lucknow regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2014-15 and 2015-16 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2014-15 and 2015-16 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2014-15 and 2015-16, the income from Gross salary is Rs.40,53,353/-, and from this amount, Rs.9600/- is deducted against GIS, Rs.4,76,828/- against GPF, Rs.7,41,810/- against IT, Rs.3,07,272/- against repayment of house loan, Rs.40,000/- against Infrastructure bond, Rs.1,10,528/- against car loan, Rs.1,00,000/- against SBI life policy, Rs.5,00,000/- given to his daughter for purchase of car, Rs.78,750/- against G.P.F. deduction and Rs.2,00,000/- deposited in his PPF account. The balance of his saving bank account (s) is enhanced to Rs.1,07,265/- from its previous year's balance. As such, total deductions /repayment/ savings/ investment is Rs.26,72,053/-. Thus, a sum of Rs.13,81,300/- was therefore available with him to meet out the household expenditure of his family consisting of two members in whole of the financial years 2014-15 & 2015-16.

In this connection it is submitted that Sri Anil Kumar Ojha, has already submitted her property statement of the financial year 2013-14 (statement is at flag 'M') which had already been seen by Hon'ble Mr. Justice Dilip Gupta the then Administrative Judge, Gorakhpur at flag 'Z'.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the years 2014-15 and 2015-16 in its next financial year i. e. in 2016-17 up to March 2017. He has
