May kindly see the letter dated 4.6.18 (at flag 'A') by which Sri Anil Kumar Ojha, Director, Judicial Training and Research Institute, Lucknow 7 has submitted his consolidated statement of movable and immovable 27/09/18 property for the financial years 2016-17 and 2017-18.

In this connection, it is submitted that as per consolidated statement of movable and immovable property for the financial years 2016-17 and 2017-18 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

In the consolidated property statements financial years 2016-17 and 2017-18, Sri Ojha total income from salary is Rs.44,85,127/- from this amount he has paid Rs.7,68,364/- against GPF, Rs.1,34,541/- against Housing loan, Rs.20,000/- against Infra Bond, Rs.50,000/- against SBI Life Insurance, Rs.9600/- against GIS, Rs.8,27,618/- against Income Tax, Rs.10,304/- against Govt. Vehicle rent. The balance of his Saving Bank Account(s) enhanced for Rs.9,19,954/- in this year. As such, total deductions /Savings/ investment are Rs.27,40,381/-. Thus a sum of Rs.17,44,746/- was therefore available with him to meet out the household expenditure of his family consisting of two members in the financial years 2016-17 and 2017-18.

The movable and immovable property statement for the financial years 2016-17 and 2017-18 has been submitted by the officer vide his letter dated 4.6.18 (flag 'A') which was due to be submitted in third financial year 2018-19 i.e. on or before 31.3.19. As such there is no delay in submitting the aforesaid Property statements from the part of officer.

In this connection, it is submitted that Sri Ojha had already submitted his property statement upto financial year 2015-16 which was seen by Hon'ble Mr. Justice Shri Narayan Shukla, Administrative Judge, Lucknow Judgeship at flag 'Z' and the statement is at flag 'M'.
