I have examined the office note dated 27.10.2009 submitted by J.R. (M), regarding sanction of Final Withdrawal of Rs. 5,00,000/- to Sri Anil Kumar Ojha, Principal Judge, Family Court, Gorakhpur vide his application dated 30.09.2009 endorsed by the District Judge, Gorakhpur (**flagged 'X'**) out of the amount which stands to his credit in his G.P. Fund account no. L.J.U.- 15768 for completion of semi constructed house of his residence.

The officer has informed to have purchased a plot no. 3/494, Vikalpkhanda, Gomti Nagar, Lucknow from Lucknow Development Authority, Lucknow and construction work has been started with the loan of Rs. 10,00,000/- from S.B.I., Gorakhpur but due to increase of building material prices, the proposed construction work could not be completed and a sum of Rs. 5,00,000/-urgently required for this purpose. He wants to complete the aforesaid semi constructed house for his residence. He has also informed that as per the estimate prepared by approved Architect, is of Rs.17,01,000/-(**flagged 'Y'**).

The aforesaid request of Sri Ojha can be considered under the provision of rule 16 (1) (c) (a), Note-2 read with Note-5 of G.P. Fund (U.P.) Rules, 1985 which is mentioned in the aforementioned office note.

The officer has sent self attested photo copy of last 4 years G.P. Fund Passbook statements and certificate dated 30.09.2009 (**flagged-'B'**) issued by the District Judge, Gorakhpur as the evidence of the amount which stands to his credit in his G.P. Fund account. The copy of G.P. Fund statement for financial year 2008-09 issued by the Sr. A.O., A.G. Office exhibit closing balance of Rs. 14,07,268/- only. As per up to date G.P. Fund Pass book statements for the years 2008-09 & 2009-10 (**flagged 'Z' & 'A'**) and aforesaid certificate dated 30.09.2009 of District Judge an amount of Rs. 14,97,390/- stands to his credit in his G.P. Fund account, out of which Final Withdrawal of Rs. 5,00,000/- may be sanctioned to him. The officer has also informed that he has already taken one Temporary Advance of Rs.50,000/- for the year 2003-04 and no recovery against Temporary Advance is pending. The officer has never taken any Final Withdrawal from his G.P. Fund account and amount of Temporary Advance has been debited



from his G.P. Fund account up to financial year 2006-07. He has put in more than 15 years of his service and his basic pay is Rs.19,600/- p.m.


Office has recommended after scrutiny Final Withdrawal of Rs. 5,00,000/- to the Officer subject to certain conditions as mentioned in the office note dated 27.10.2009 for completion of the residential house.
